**AN ORDINANCE OF THE TOWN OF EAGLE, COLORADO, AMENDING CHAPTER
12.20 OF THE EAGLE MUNICIPAL CODE BY REVISING THE VARIABLE RATE
SURCHARGE SCHEDULE FOR WATER SERVICE ACCOUNTS**

WHEREAS, the Board of Trustees of the Town of Eagle finds and determines that the Town's variable rate surcharge schedule for municipal water service should be revised as hereinafter set forth;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF EAGLE, COLORADO:

Section 1. That Section 12.20.110(B) of the Eagle Municipal Code is hereby amended to read as follows:

B. Beginning on the first day of September 2018, and on the first day of the month thereafter, the following surcharges shall be assessed and charged:

Surcharge Category	Average Monthly Usage (gal)		Monthly Surcharge
	Residential	Non-Residential	
1: Low Usage	0 – 4,000 gallons	0 – 2,000 gallons	\$ 8.15
2: Average Usage	4,000 - 14,000 gallons	2,000 – 46,000 gallons	\$ 12.50
3: High Usage	> 14,000 gallons	> 46,000 gallons	\$ 17.00

Section 2. This Ordinance shall become effective on September 1, 2018.
