Introduction

This Natural Resource Management Plan (management plan) for the Haymeadow and Spud Cellar Open Spaces, and adjacent Haymaker Trailhead in Eagle County, Colorado (properties) is intended to assist with recommendations for natural resource concerns that impact the existing, as well as future, conditions based on management objectives set forth in the 1997 Open Lands Conservation Plan and the 2022 Open Space and Trails Master Plan. Some of these natural resource concerns include noxious weed management, wildlife habitat conservation, and visitor use management measures.

Location and Background

The properties consist of approximately 115 total acres located along the middle northern perimeter of the Town of Eagle (Eagle or Town), Colorado generally accessed from Brush Creek Road (**Figure 1**).

The open space properties are located on the northern boundaries of Eagle with elevations ranging between 6,716 and 6,893 feet. These areas are largely undeveloped aside from trailhead access areas, trails, and access roads (**Figure 6**). These open space properties consist of mainly disturbed grasslands, pinyon juniper woodlands, sagebrush shrublands, and sand hillslopes and are bound by land owned and managed by the Bureau of Land Management (BLM) Colorado River Valley Field Office to the northeast and south and residential lands to the northwest.

Planning Context

The Town of Eagle completed a master planning process in 2022 which prioritized the need for the creation and implementation of management plans for its 12 open space properties and neighborhood connections identified in the Open Space and Trails Master Plan.

Purpose of the Management Plan

The purpose of this management plan is to provide an assessment of existing natural resources, and to guide resource management at the property. More specifically, this management plan is also intended to achieve the following objectives:

1. Document existing conditions and resource management issues on the property.
2. Identify and prioritize strategies to address resource management issues and maintain the overall integrity of resources on the property.

Management Plan Process

The Town of Eagle hired ERO Resources Corporation (ERO) to complete this management plan. The planning process included the following phases:

1. **Focus Group Meetings (June 2023):** Meetings with focus groups to discuss issues and objectives related to natural resource and recreation management.
2. **Resource Assessment (June – July 2023):** Evaluation of existing resource data, and field assessments of open space properties.
3. **Public Survey (July – August 2023):** Online survey to assess community preferences around key open space management topics (**Appendix A**).
4. **Draft Management Plan (September – October 2023):** Completion and public review of draft management plan.
5. **Final Management Plan (November – December 2023):** Completion and adoption of final management plan.

Public Engagement

During the management planning process, it was important that the Town of Eagle provide several opportunities for public input. Engagement with the community included two online survey opportunities – one at the outset of the planning process and one after draft management plans and policy papers were available for public review. Additionally, the Town held a public open house on Wednesday October 18th, 2023, at the Brush Creek Pavilion which included poster boards of maps and plan components as well as a presentation led by ERO Resources. Over 130 community members attended the open house. Additional details regarding public engagement results can be found in **Appendix A**.

Relationship to Existing Plans and Policies

This section describes the various land use considerations associated with the property.

Open Lands Conservation Plan

In 1997, the Town of Eagle adopted its Open Lands Conservation Plan which established open space dedications in the town. This plan introduced four objectives for managing open space properties.

- Conserve Natural Characteristics

- Protect Critical Wildlife Habitat
- Provide Appropriate Recreational Opportunities
- Maintain Scenic Qualities

These objectives were discussed and evaluated during the Open Space and Trails Master Plan process. Stakeholders, the public, and staff reaffirmed these objectives during the planning process and saw no reason to change them based on current and future open space needs.

Open Space and Trails Master Plan

In July of 2022, Eagle adopted the Open Space and Trails Master Plan (OST Plan) which prioritized the need for creating management plans for its open space properties (Eagle 2022). One of the primary goals of the OST Plan is to “inventory conditions and improve understanding of open space” by monitoring and managing natural resource conditions in Eagle’s open spaces in accordance with best practices and management plans. Recommendation OS8, Development of Open Space Management Plans, is rated as a high priority under Eagle’s OST Plan and further supports the need for understanding the existing conditions to provide the Open Space Department with a framework for future budgeting, partnerships, and capacity building.

Town of Eagle Municipal Code

Open space in Eagle is regulated by Title 6 and Title 9 of the Municipal Code (Eagle 2023). Title 6 Public Parks, Recreation Areas, and Open Space Areas regulates the types of uses allowed and disallowed on open space properties, procedures for proposing new trails on open space, and special events on open space. Title 9 Public Peace, Safety, and Morals includes Chapter 9.26 Public Parks, Recreation Areas, and Open Space Areas which regulates public sanitation, behavior, and need for preservation of open space.

Haymeadow Development and Dedications

A 32.82-acre parcel, Tract E, was deeded to the Town as a School and Recreation site during the first filing of the Haymeadow PUD. Upon request of the Eagle County School District, a portion of the parcel would be conveyed to the school district, when they see a need for a new school. The school is proposed to be located on the southern portion of the property and the amount of land needed for the school will be determined by the school district at a future point when and if there is a need. Until such a point, the developer will be responsible for irrigation of the southern portion of the property. This parcel has been identified as low quality, weed-dominated habitat, and an Ecological Restoration Plan was developed for this parcel in 2018. This plan outlines restoration and weed management practices to be undertaken on the parcel. With the approval of a major PUD amendment on December 8, 2021, 6.5 acres will be removed from Tract E on the northeastern side and instead will be used for housing. Haymeadow will dedicate 8 acres for a future park/recreation site at a later point in the development. In partnership with Mountain Recreation, the Town intends to develop a new site plan for the Haymaker Trailhead and recreation site. Land in the northwestern portion of Tract E is proposed to be included in

the site plan. Likely elements of this site plan include an expansion of the trailhead, overflow parking, and a bike park. Additionally, the Town required the developer to create these additional management plans as part of Filing 1. These new plans will provide more detail and management recommendations.

The Town of Eagle Open Space and Trails Department helps manage the Haymaker Trailhead with the Mountain Recreation District and Town of Eagle Public Works, though it is not zoned as Open Space and instead as a Public Area. This 7-acre area is within a larger 19.2-acre parcel owned by the Town and includes the Haymaker parking lot, BMX track, RC car park, shade structure, pump track, and the access to the Haymaker trail. Eagle's Pool and Ice Rink complex is located on the larger parcel, as are tennis courts and other recreation amenities.

Haymaker Trailhead Master Plan

The Haymaker Trailhead Area Master Plan developed a program and plan for improvements to the existing Pool and Ice Rink and adjacent Haymaker Trailhead to address the current and future recreation needs for the growing population of Eagle (Mountain Recreation 2020). The master plan also addresses broad goals for pedestrian connectivity to facilities and surrounding public lands, energy efficiency for development of public facilities, and recreational amenities and facilities which support a variety of sports and activities. This effort was led by the Town of Eagle and Mountain Recreation.

Adjacent Public Lands and Planning Efforts

Eagle County Open Space

The Eagle County Open Space program manages and conserves upwards of 15,000 acres of land throughout Eagle County (Eagle County 2023). The Eagle Ranch Open Space property shares boundaries with Brush Creek Valley Ranch.

Colorado River Valley Field Office Resource Management Plan

The Bureau of Land Management (BLM) manages its public lands through field office-specific Resource Management Plans (RMP). The Colorado River Valley Field Office manages BLM lands which are adjacent to the Abrams Creek and Eagle Ranch Open Space properties in accordance with the Colorado River Valley Field Office RMP (BLM 2015). The Haymeadow parcels abut BLM lands to the north which are also subject to the RMP.

White River National Forest Plan

The U.S. Forest Service (USFS) does not own property adjacent to Eagle Open Space, though it does share boundaries with adjacent BLM lands. The White River National Forest (WRNF) manages its land through a management plan in accordance with the National Forest Management Act to establish protection measures, management strategies, and goals and guidelines for appropriate uses (USFS 2002).

Coordination and planning efforts among land managers are ongoing and continue to be a positive relationship for the Town of Eagle.

Existing Conditions

Geology and Soils

The NRCS mapped five map units on the open space properties. The description for each soil and its series are shown below and include uses that might be common on the soil type. **Figure 2** shows the soil mapping for the property. All soil information was gathered from the NRCS Soil Series Description query site (NRCS 2023) and the Soil Survey of Aspen-Gypsum Area, Colorado, Parts of Eagle, Garfield, and Pitkin Counties (USDA 1992).

Evanston loam, 1 to 6 percent slopes

The Evanston loam series consists of deep, well drained soils on alluvial fans, terraces, and valley sides. These soils formed in mixed alluvium. The slope ranges from 1 to 6 percent. The average annual precipitation is 14 inches, and the average annual temperature is 44°F.

Gypsum land-Gypsiorthids complex, 12 to 65 percent slopes

The Gypsum land-Gypsiorthids complex series consists of extremely shallow, high runoff class soils on hills, drainageways, and mountains. These soils formed in mixed colluvium and/or mixed residuum. The slope ranges from 12 to 65 percent. The average annual precipitation is 12 inches, and the average annual temperature is 42°F.

Redrob loam, 1 to 6 percent slopes

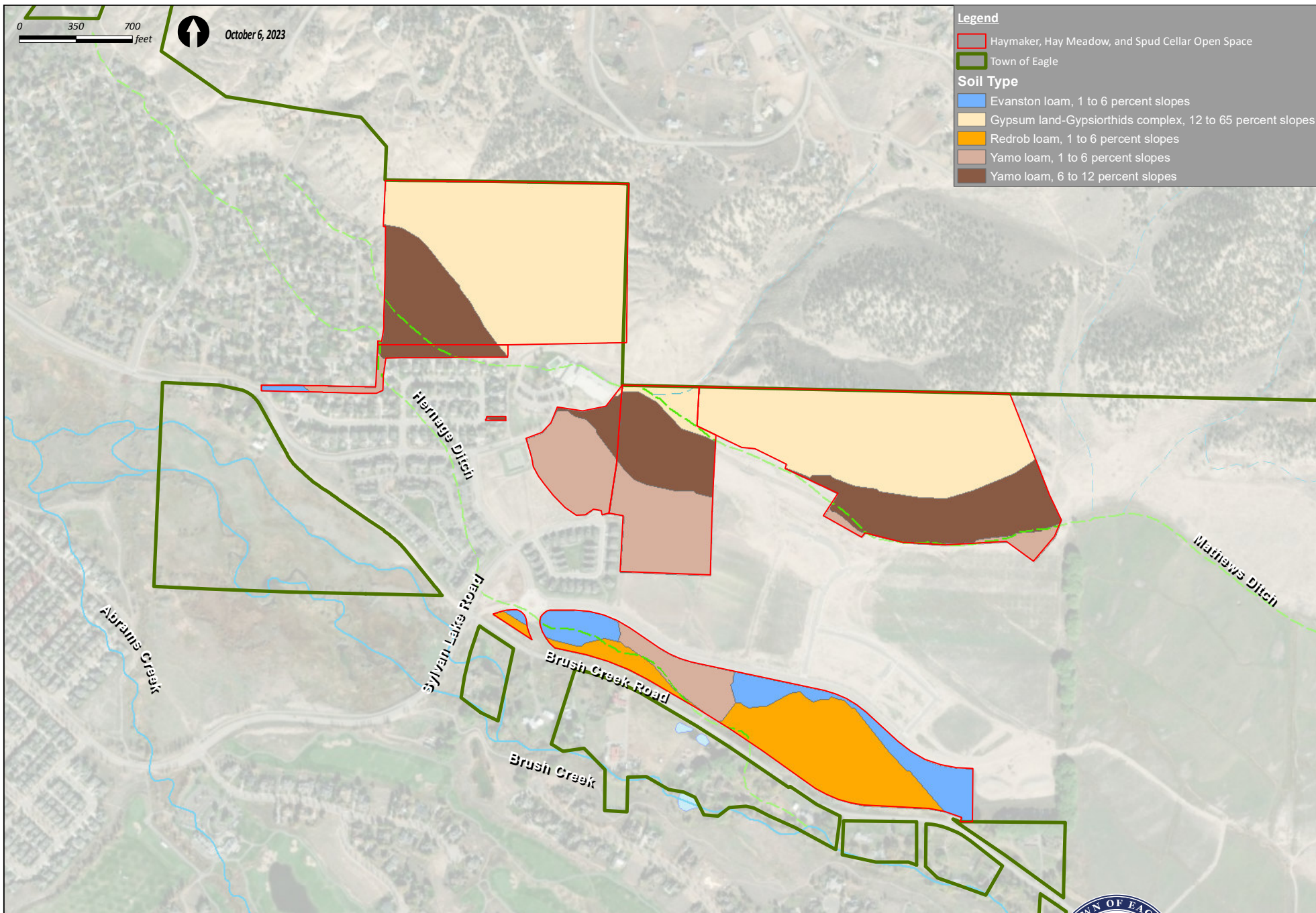
The Redrob loam series consists of deep, somewhat poorly drained soils on valley floors, terraces, and floodplains. These soils formed in mixed alluvium derived from sandstone and shale. The slope ranges from 1 to 6 percent. The average annual precipitation is 17 inches, and the average annual temperature is 42°F.

Yamo loam, 1 to 6 percent slopes

The Yamo loam series consists of deep, well drained soils on fans and mountains. These soils were formed in colluvium derived from sandstone and/or colluvium derived from shale and/or colluvium derived from gypsum. The slope ranges from 1 to 6 percent. The average annual precipitation is 12 inches, and the average annual temperature is 42°F.

Yamo loam, 6 to 12 percent slopes

The Yamo loam series consists of deep, well drained soils on fans and mountains. These soils were formed in colluvium derived from sandstone and/or colluvium derived from shale and/or colluvium derived from gypsum. The slope ranges from 6 to 12 percent. The average annual precipitation is 12 inches, and the average annual temperature is 42°F.

Water Resources

There are no creeks, lakes, or ponds located on these properties. Two ephemeral drainages are shown on the USGS topo maps, however both lack a defined bed and bank.

Vegetation Resources

Colorado Natural Heritage Program

The Colorado Natural Heritage Program (CNHP) maintains a tracking list and serves as the central data repository for Colorado's rare flora. Many of these species are also considered species of conservation concern by the U.S. Fish and Wildlife Service (USFWS), the U.S. Forest Service (USFS), the Bureau of Land Management (BLM), and the Colorado Department of Natural Resources (CNHP 2023). Although Harrington's penstemon (*Penstemon harringtonii*) was not observed in the open space, it has been observed in the open space along the Eagle River to the north and the Eagle Ranch and Abrams Creek open space to the south. Additionally, the sagebrush shrublands provide suitable habitat Harrington's penstemon.

Harrington's Penstemon

Harrington's penstemon habitat is described as sagebrush shrubland and mixed mountain shrublands. Harrington's penstemon occasionally occurs in disturbed grassland and pinyon juniper woodlands and it is not known whether Harrington's penstemon is limited to specific geologic substrates or soils (USFS 2006). Harrington's penstemon has been documented on all aspects in Colorado and on slopes as steep as 50 percent but is usually found on slopes less than 20 percent (CNHP 2023). Additional background on this species is provided in **Appendix B**.

Disturbed Grasslands

The disturbed grassland community occurs to the south and east of the BMX track. Vegetation in this community is dominated by a mixture of non-native grasses and forbs including smooth brome (*Bromus inermis*), crested wheatgrass (*Agropyron cristatum*), kochia (*Bassia scoparia*), sweet clover (*Melilotus officinalis*), bulbous bluegrass (*Poa bulbosa*), cheatgrass (*Bromus tectorum*), Russian thistle (*Salsola tragus*), prickly lettuce (*Lactuca serriola*), and lambsquarter (*Chenopodium album*). Wyoming ground squirrel (*Urocitellus elegans*) are prevalent in the disturbed grassland community.

Pinyon Juniper Woodlands

The pinyon juniper woodland community generally occurs on hillslopes in the open space. This community is dominated by an overstory of pinyon pine (*Pinus edulis*) and Rocky Mountain juniper (*Juniperus scopulorum*). Other prevalent shrub species include big sagebrush (*Artemisia tridentata*), mountain mahogany (*Cercocarpus montanus*), and antelope bitterbrush (*Purshia tridentata*). Herbaceous understory cover is sparse in this community and is dominated by sand bluegrass (*Poa secunda*), bluebunch wheatgrass (*Pseudoroegneria spicata*), and western wheatgrass. This community is relatively undisturbed except for impacts from existing trails.

Sagebrush shrublands

The sagebrush shrubland community occurs on hillslopes and valley bottoms in the open space. This community is dominated by big sagebrush and less prevalent shrub species include rubber rabbitbrush (*Ericameria nauseosa*) and woods rose (*Rosa woodsii*). The herbaceous layer is dominated by smooth brome, fringed sage (*Artemisia frigida*), western wheatgrass (*Pascopyrum smithii*), basin wildrye (*Elymus cinereus*), Indian paintbrush (*Castilleja sp.*), sulfurflower buckwheat (*Eriogonum umbellatum*), hairy false golden aster (*Heterotheca villosa*), pussytoes (*Antennaria sp.*), yarrow (*Achillea millefolium*), and Indian ricegrass (*Eriochloa hymenoides*). This community is relatively undisturbed except for impacts from existing social trails.

Sand Hillslopes

The sand hill slopes community occurs on steep hillslopes mapped as Gypsum land gyrsolrithids complex and contain sparse vegetative cover. Where vegetation is present it is dominated by Indian ricegrass, fringed sage, snowball sand verbena (*Abronia fragrans*), broom snakeweed (*Gutierrezia sarothrae*), and squirell tail (*Elymus eloides*).

Wetlands

Wetlands occur along the Hernage ditch in the open space. The wetlands are classified as palustrine emergent wetlands and dominant species include reed canarygrass (*Phalaris arundinacea*), Baltic rush (*Juncus balticus*), nebraska sedge (*Carex nebrascensis*), and meadow foxtail (*Alopecurus pratensis*). List B noxious weeds including Canada thistle (*Cirsium arvense*) and white top (*Lepidium draba*) occur in the wetlands are spreading from the disturbed upland community adjacent to the wetlands.

Noxious Weeds

No List A species were found in the project area during the 2023 site visit. Two CDOA Noxious Weed List B species and three List C species were identified in the project area during the 2023 site visit (CDOA 2020). The locations of List B are shown on **Figure 3**. Noxious weed populations are most prevalent in areas disturbed by the Wyoming ground squirrel populations south and east of the BMX track.

Additionally, there is a noxious weed management plan for the open space properties in Haymeadow. The Town is responsible for enforcement of the plan, but the developer is responsible for noxious weed

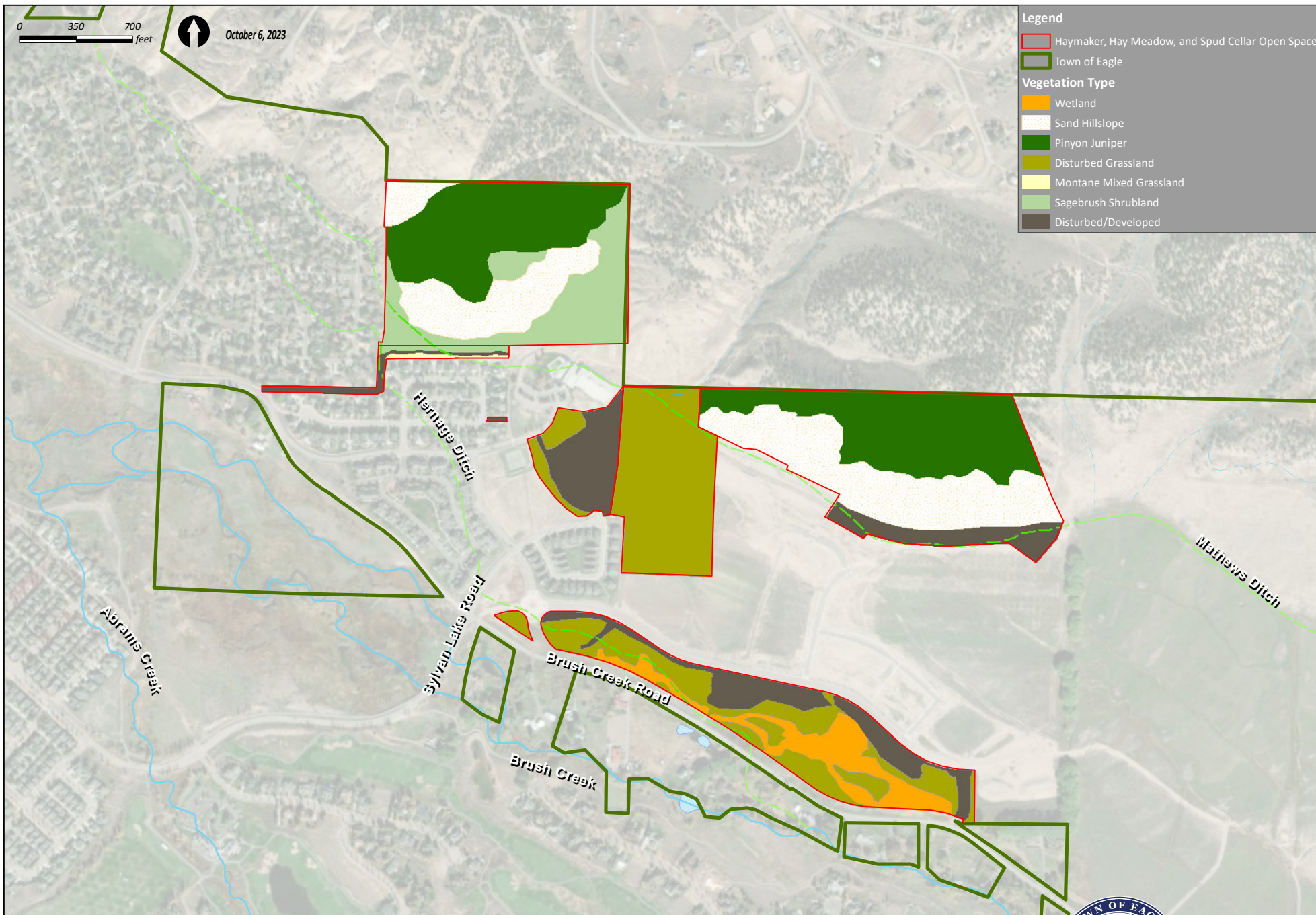
treatments in open space and the irrigated field of Tract E. Reference and coordination between this plan and the noxious weed management plan should ensure consistent approaches.

Wildlife Resources

This section includes a discussion of general wildlife species that are likely to occur on the open space properties, as well as federal- or state-listed sensitive species, USDA FS sensitive species, and Eagle County species of special concern.

General Wildlife

The open space properties provide habitat for a variety of wildlife species typical of the montane life zone in Eagle County. Mammal species likely to occur include black bear, mountain lion, elk, mule deer, fox, bobcat, and coyote. Other common mammals potentially occurring on the property include mountain cottontail rabbit, snowshoe hare, western spotted skunk, raccoon, pine squirrel, chipmunk, and a variety of mice and shrews.

The property also provides habitat for a variety of migratory songbirds such as mountain bluebird, scrub jay, Steller's jay, Brewer's sparrow, Virginia's warbler, Lewis' woodpecker, and spotted towhee. Common raptors include red-tailed hawk, American kestrel, and great horned owl.

Seasonal Closures

As of December 2022, a seasonal closure for Town of Eagle Open Space and Trails is enacted annually from December 1 - April 15. During the closure period, trails are closed to all human activity to protect wintering habitats for species like elk and mule deer. The Haymaker Trail's first two loops are open to activities as normal, and the second two loops are closed as part of the seasonal closure. The Spud Cellar Trail is also closed as part of the seasonal closure. The gravel path through the wetlands parcel, the bike park, BMX track, trailhead, and the open space properties themselves are not subject to seasonal closures.

Federally-Listed Wildlife Species

Federally threatened and endangered species are protected under the Endangered Species Act (ESA) of 1973, as amended (16 United States Code 1531 et seq.). Significant adverse effects on a federally listed species or its habitat require consultation with the U.S. Fish and Wildlife Service (Service) under Section 7 or 10 of the ESA. The property contains, or is located near, potential habitat for the federally-listed species shown in **Table 2**.

Species of Management Interest

CPW tracks a number of species that are regionally important for big game hunting and overall conservation, including sensitive or seasonal activity areas for several species. Habitat Integrity

In any natural landscape, the development of roads and trails fragments habitat values by disrupting ecological processes and contiguity, increasing erosion and vegetation loss, and introducing linear edges and corridors that become pathways for predators and nonnative species. Habitat fragmentation reduces the size and overall integrity of habitat areas and is detrimental to many species (Noss and Cooperrider 1994; Groves et al. 2002; Decker 2018). Roads and trails, and the human access and use that they support, exacerbate these impacts by creating a “zone of influence” within which human disturbance may alter wildlife behavior and reduce the value of habitat to some wildlife. The impacts of fragmentation vary by species and individual animal and can range from no effect, to interruption of activity, to flight, to abandonment of breeding or foraging sites. This zone of influence can range from 30 to 400 meters or more, depending on terrain, vegetation, species, and levels of human use and prior habituation (Miller et al. 2001; Taylor and Knight 2003; Stankowich 2008; Cassirer et al. 1992; George and Crooks 2006; Naylor et al. 2009; Malone and Emerick 2003; Miller et al. 2020; CPW 2021).

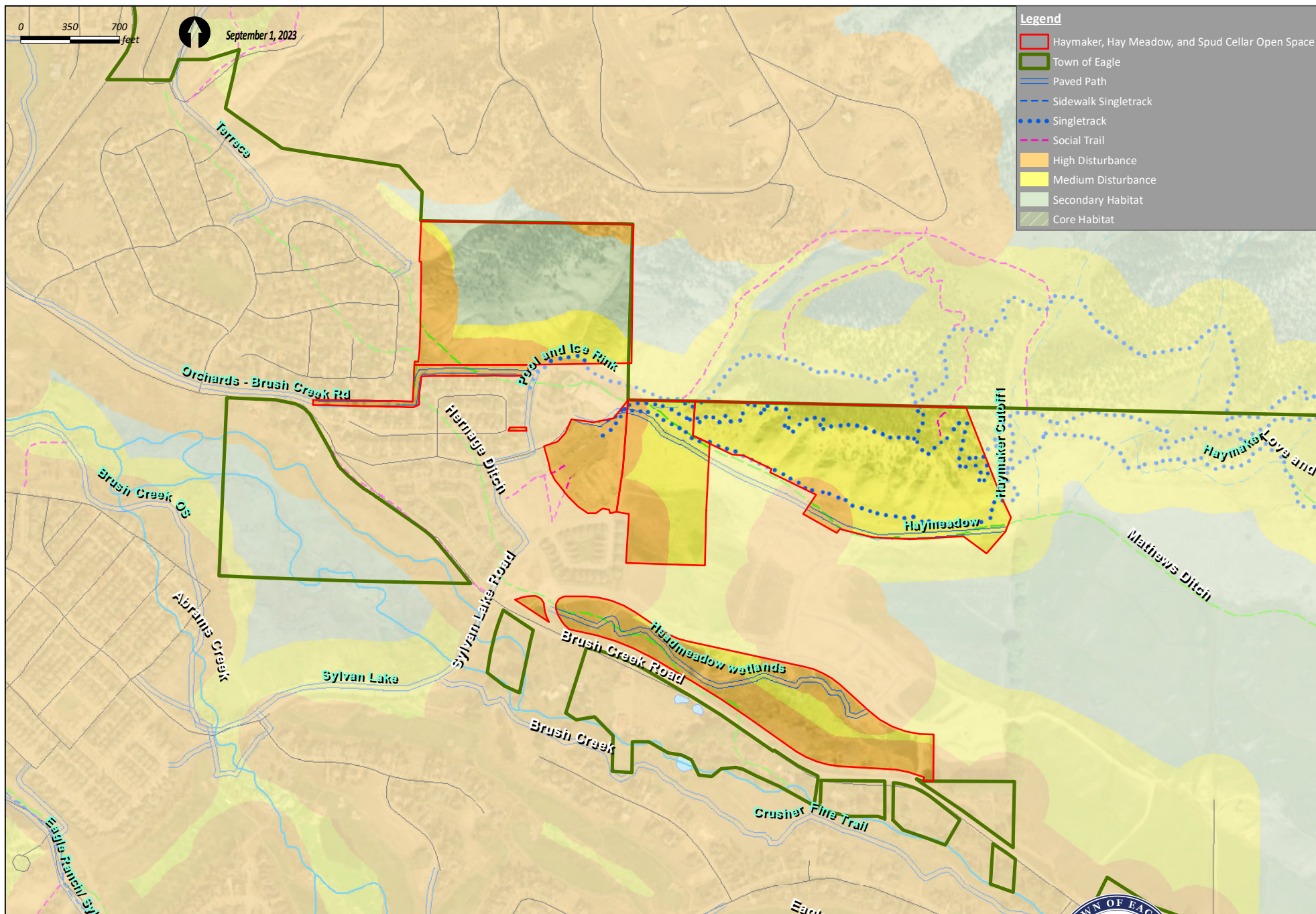
Habitat Disturbance Analysis

Considering the broad range of impact distances, the existing conditions and context of the property, and other factors, the following analysis of existing and future habitat fragmentation uses a range of 100 to 400 meters as the zone of influence for existing and proposed roads and trails. Four disturbance levels are mapped in this analysis (**Figure 5**) and analysis definitions are described below.

Habitat Fragmentation Analysis Definitions

1. **High Disturbance Areas** – Frequent or permanent human occupation; each of the following with a 100-meter impact zone:
 - a. Existing homes, urban streets, major roads, and highways
 - b. Provides limited habitat value for wildlife, with local exceptions
2. **Medium Disturbance Areas** – Frequent but not permanent human occupation; 100-meter impact zone:
 - a. Existing trails, secondary roads, and recreation facilities
 - b. Provides degraded habitat for wildlife that are accustomed to human disturbance
3. **Secondary Habitat** – Infrequent human occupation, or expanded influence from high or medium disturbances; 400-meter impact zone, or 100-meter buffer from sparsely used social trails
 - a. Provides intact habitat for most wildlife, but human activity may impact wildlife behavior and use, depending on the species and context
4. **Core Habitat** – No human development and minimal human presence; greater than 400 meters from any disturbance
 - a. Provides secure, undisturbed habitat for any species where sufficient habitat otherwise exists

The habitat disturbance analysis for the property is shown on **Figure 5**.

Recreation Resources

Haymeadow, Spud Cellar, and the Haymaker Trailhead have many opportunities for open space recreation (**Figure 6**). Hiking and biking are popular trail uses in these areas and users are able to continue their hike or ride on adjoining BLM lands and trails. There is no motorized use allowed in these open spaces.

The Conservation Easement for Spud Cellar specifically elevates wildlife habitat as the primary conservation value of the property which limits recreation potential on the property.

Trails

Table 4 below describes trail distances and allowed uses.

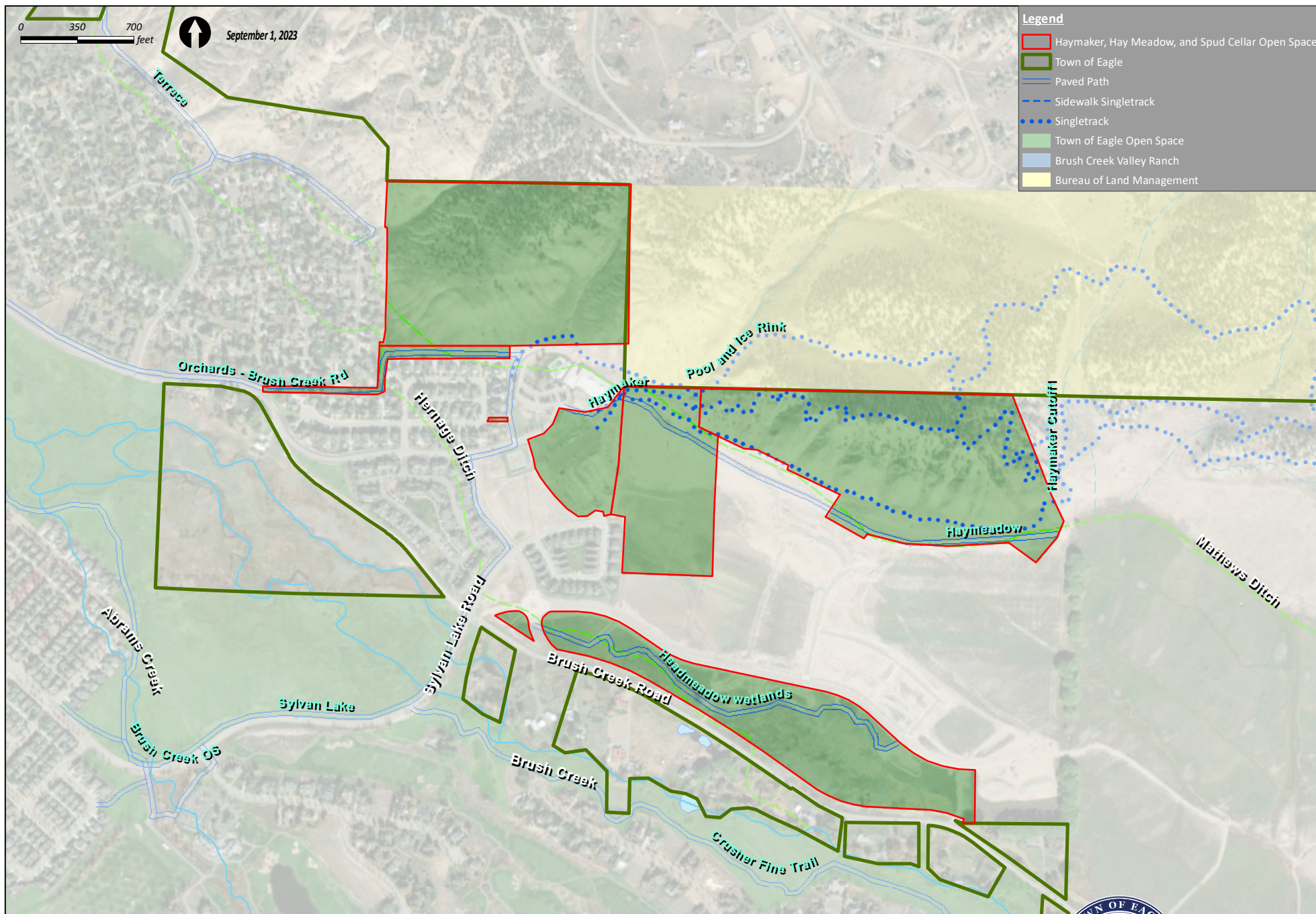

Trailheads

The largest trailhead in Eagle is the Haymaker Trailhead. The trailhead consists of approximately 90 parking spaces, two portable restrooms and changing areas, and an information kiosk. The trailhead provides access to the Pool and Ice Rink amenities, the BMX park, trails, and tennis courts.

The Vail Valley Mountain Trails Alliance is currently building a bike park as part of their own master planning efforts.

Resource Management Plan

Implementing this management plan will require identification and prioritization of management actions to maintain proper stewardship of the natural resources on the property. These prioritized management actions should continue to be reviewed on an annual basis to determine yearly work programs given budget and staff constraints. Many of the management actions will be implemented within the first few years, while others will take many years to accomplish. Some management actions are ongoing, some are short-term, and others are long-term, representing considerable investments of time and energy.

Resource Management Issues

Resource management issues are specific occurrences or situations that can compromise the natural resource values on the property. Known or potential resource management issues for the property are listed below in **Table 5** and addressed with management actions.

Table 5. Resource management issues.

Resource Management Issues
Habitat Management • Fuels management – Fuels management efforts by Eagle Valley Wildland present opportunities for habitat enhancement but require ongoing coordination and follow up to ensure ecological benefits. This area has the lowest risk of wildfire according to the Colorado State Forest Service. • Trash cleanup – Ongoing removal and cleanup of structures, social trails, and debris on Spud Cellar is necessary for safety and resource protection. Vegetation Management • Noxious weeds – Invasive and noxious weed species are a persistent threat to native habitat quality and diversity and require ongoing monitoring and management. • Disturbed grasslands – Former disturbed areas are dominated by nonnative pasture grasses and weedy species, have limited habitat value for wildlife, and could facilitate noxious weed infestations. • Revegetation – Revegetation of disturbed and reclaimed areas associated with construction or other disturbances is an ongoing challenge to establish native species and minimize noxious weed infestations. Wildlife Management • Pest management – Populations of Wyoming ground squirrel and other pest species degrade vegetation and other resources, and result in conflicts with visitors, dogs, and neighboring property owners. • Big game winter range protection – Ongoing management of human use and habitat is necessary to protect critical winter ranges for deer and elk. Recreation Management • Trail access – Undesignated visitor access to trails and other amenities from neighborhoods has resulted in vegetation trampling, social trails, and erosion. • Public land interface – Unclear property boundaries, illegal encroachment and use, and unauthorized trail access could result in resource damage and a loss of public stewardship of open space. • Winter recreation use – Winter recreation management on the Haymaker trail system is necessary to protect critical ranges for deer and elk.

Resource Management Strategies

Management strategies for the property, including goals, objectives, and actions, are presented in **Table 6**, along with the recommended timing and priority of implementation. Resource management topics in order of priority include:

- Recreation and Access Management
- Vegetation Management
- Wildlife Management
- Habitat Management

A more detailed discussion of key management issues is presented below. Management strategies are also shown on **Figure 7**.

Key Management Issues

Noxious Weed Management

Prioritizing nonnative and noxious weed management efforts is needed since attempting to control all nonnative and noxious weeds on the property can be unrealistic and unsuccessful. A recommended strategy for noxious weed management is to minimize the spread of existing weed infestations and reduce, over time, the extent of noxious weeds on the property. Attempting to control all weeds can be overwhelming and ultimately unsuccessful, so it is important to implement a strategy that includes the following principles: (1) promote the health and persistence of desired native or stable nonnative species; (2) focus weed control and management on new infestations; (3) prioritize efforts based on the State of Colorado's priority species list (A, B, and C); and (4) integrate weed management into all ground-disturbing projects.

A successful weed management strategy will incorporate regular (annual) monitoring; integration of a variety of tools including herbicides, mowing, and biological controls; and prioritization of weed abatement efforts. Generally, addressing smaller infestations of highly invasive species is recommended rather than larger infestations of species that are easier to control.

Revegetation

Revegetation practices help establish native plant communities in disturbed areas, and to improve the overall quality and vigor of other degraded areas.

Steps to implement include:

- Salvage and test the existing topsoil for revegetation efforts; do not use topsoil from areas infested with noxious weeds.

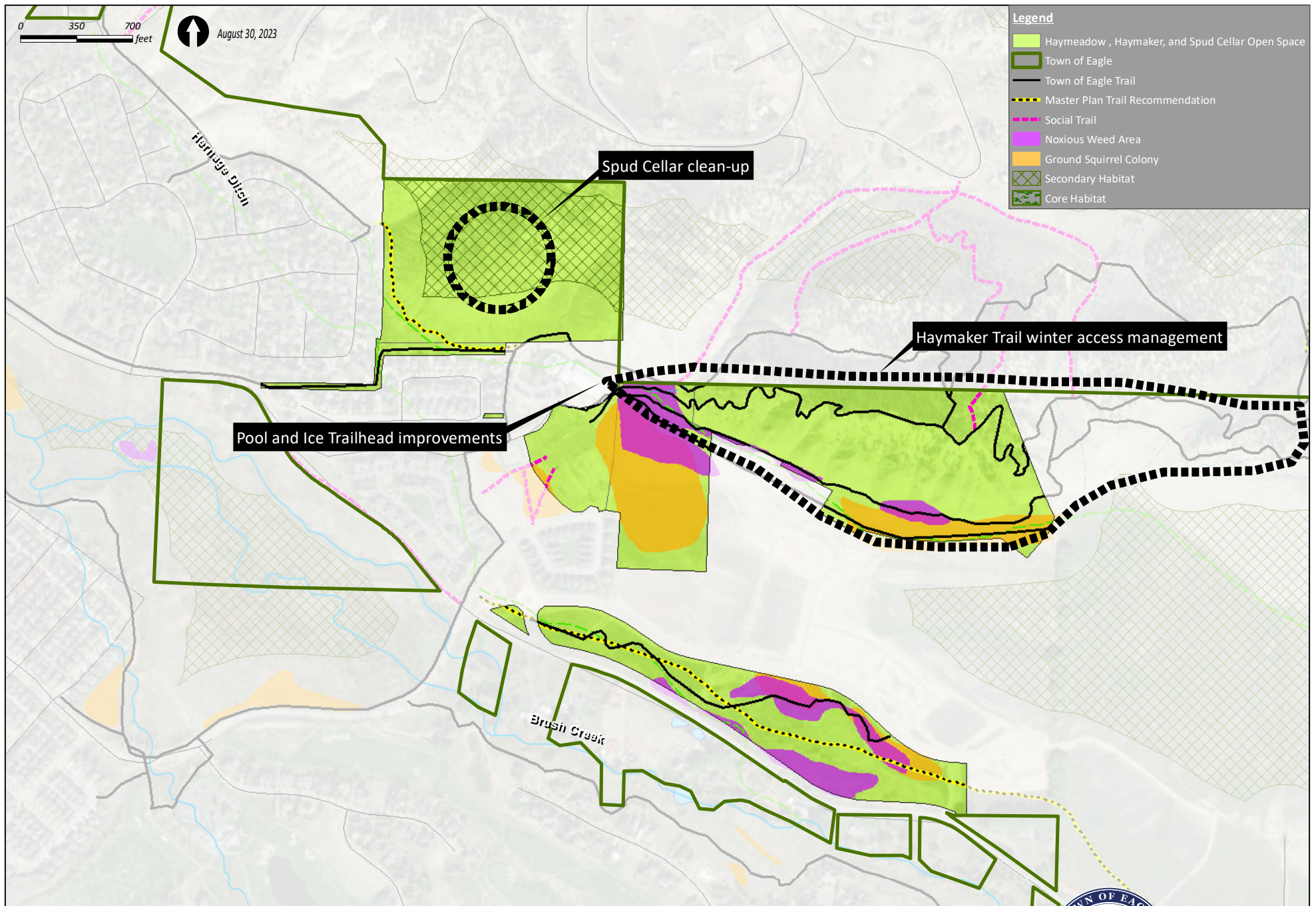
- Supplement topsoil with amendments if testing indicates a deficiency in structure, organic matter, or nutrients.
- Grade, rip, or till the disturbed soils to relieve compaction and prepare the sites for seeding.
- Place topsoil and drill seed upland areas with the upland seed mix in the fall (prior to freezing) or spring (after thaw).
- Place topsoil and broadcast seed wetland areas with the wetland seed mix in the fall or spring.
- Apply mulch to seeded areas within 24 hours of seeding.
- Monitor seeded areas on a monthly basis for erosion, noxious weeds, or large areas of bare ground until desired species are well-established; correct issues immediately.

Harrington's Penstemon Conservation

Most of the sagebrush-dominated habitats in this area provide potential habitat for Harrington's penstemon (*Penstemon harringtonii*), a rare plant species that is unique to region. It occurs on all aspects in open sagebrush and mixed pinyon-juniper or mountain mahogany shrublands on gentle slopes of usually less than 20 percent. As shown on **Figure 3**, most of the open space in this area provides potential habitat for this species. To support the long-term conservation of this species, the following measures are recommended for any ground-disturbing activities within identified potential habitat:

1. Survey proposed project areas during the survey period (June)
2. If found, evaluate or modify the proposed project to avoid ground disturbance within a 100-foot buffer of all confirmed plants
3. If a 100-foot buffer cannot be implemented, avoid direct ground disturbance where plants are rooted.
4. If direct ground disturbance cannot be avoided, adjust the project site or alignment to minimize impact to the plants, with the goal of having less than 1 to 2 percent of the population within the project impact area.
5. If the project site or alignment cannot be changed to minimize impacts, confine disturbances as close to outer edge of the plant population as possible to minimize fragmentation.
6. If plants are unavoidable, contact nearby botanical gardens or grow out facilities (such as the Betty Ford Alpine Garden in Vail and the Upper Colorado Environmental Plant Center facility in Meeker; these facilities have accepted salvaged plants in the past) to salvage plants if possible.
7. Weed control efforts should not include broadcast or aerial herbicide treatments within ½ mile of known populations. Utilize spot spray application in these areas.
8. Construction within identified *P. harringtonii* habitat should occur during the active growing season (May 15 through August 30) to ensure that all rosettes are visible.
9. Monitor on-site construction with a qualified biological monitor (botanist) to avoid and mitigate impacts to populations.

Additional background information on Harrington's penstemon is found in **Appendix B**.

For the purposes of this section of this management plan, the following terminology applies:

- **Objective** – Objectives are the outcomes that are intended to be achieved through management actions.
- **Action** – Actions are the specific tasks that the owners can undertake to address issues and meet the objectives.

Timing recommendations are defined as follows:

- **ST (short-term actions)** – Should be completed within 1 year.
- **LT (long-term actions)** – Should be initiated or completed within 5 years.
- **O (ongoing actions)** – Should be completed on an ongoing annual basis indefinitely.

Priority recommendations are defined as follows:

- **H (high-priority actions)** – Should be accomplished first. These management actions are considered extremely important to the protection of resource values.
- **M (medium-priority actions)** – Considered important but not urgent, and meet a combination of other objectives.
- **L (low-priority actions)** – Important but not critical to resource protection needs. Low-priority management actions do not have to be completed in the immediate future and primarily fulfill a specific resource objective.

Monitoring

Routine monitoring of specific resources and specific management issues will be necessary to document the ongoing trajectory of management issues and to determine how well management objectives are being met. Ongoing monitoring allows Eagle to make informed decisions about resource management priorities and projects and provides a feedback mechanism that facilitates ongoing learning about resource issues and improvement of techniques to address them.

Monitoring recommendations are listed above as management actions and are repeated in **Table 7** to provide a quick reference.

Town of Eagle Open Space and Trails Management Plans Online Survey Summary

Summary

As part of the Open Space management planning process, public input was needed to understand community sentiments around natural resource and recreation management on Eagle open space.

One form of soliciting community input was through a public survey. The survey link was posted on the Town of Eagle's website, at trailheads, on social media, and in various community newsletters. There were 802 responses to the survey, and it remained open for four weeks (from July 17 to August 18, 2023). Below are the results of the survey.

General Survey Results

There were 802 responses to the survey with 76% of respondents reporting they reside in the Town of Eagle. Over 70% of respondents reported visiting open space multiple times per week and over 20% reported visiting open space one to two times per month. Less than one percent of respondents reported never having visited Eagle open space or trails.

The majority of survey respondents felt the management of Eagle open space was "good, but more could be done." Less than five percent of respondents thought management of open space was "poor."

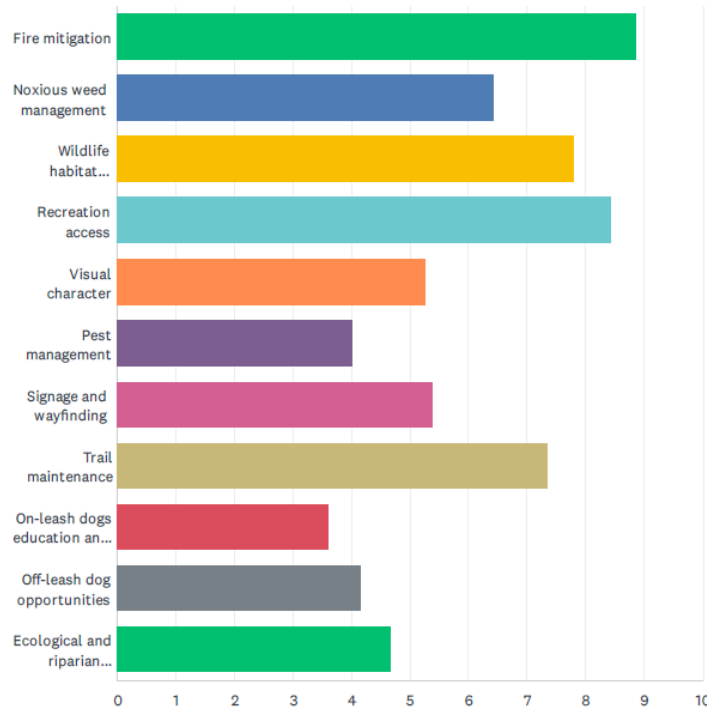
Detailed Survey Results

A series of questions asked about resource management priorities, recreation access/wildlife closures, and motorized access on open space. **Note:** Each substantive survey question result is shown in Survey Monkey generated tables and additional tables in the attached Appendices to compare the survey results for Town of Eagle residents with those of all respondents to the survey.

The first of these questions asked what respondents felt the recreation/natural resource management priorities should be on open space. Respondents ranked the management concerns from 1 to 11 (1 being the highest priority). The top 3 management priorities reported by respondents were fire mitigation, recreation access, and wildlife habitat improvements, respectively. Pest management, on-leash dog education and enforcement, and off-leash dog opportunities were among the lowest priorities for respondents. These responses were similar to those of Eagle residents only.

(1 being the highest priority and 11 being the lowest)

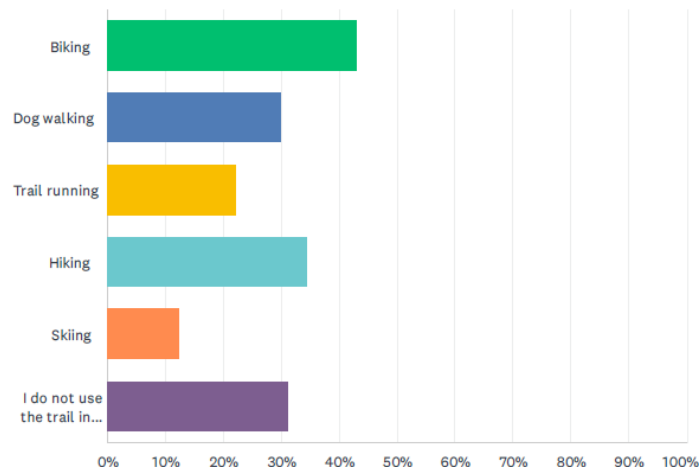

Next, respondents were asked to select their preferred winter use of the Haymaker Trail system. The number one response, with more than 42% of respondents, said their preferred winter use of the trail system was biking. Over 30% of respondents said they do not use the trail system during the winter. Biking was also the number one use for winter recreation on Haymaker for Eagle residents and similarly (around 30%) for those who do not use the trail system in the winter.

(check all that apply)

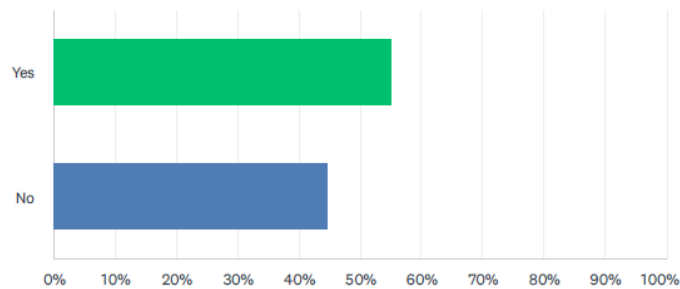

Additionally, respondents were asked if they would support additional winter restrictions on Haymaker to protect wildlife. Respondents were mostly split on this issue, 55% supported additional restrictions and 45% did not support additional restrictions. The results were almost identical for Eagle residents only.

Q6 Would you support additional winter restrictions on the Haymaker Trail system to protect wildlife?

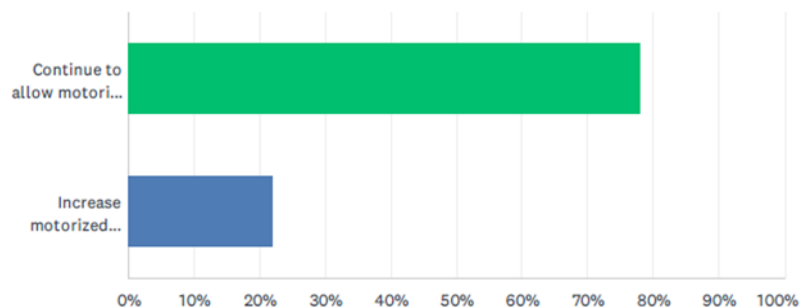

Question 7 asks the participants about their preferences regarding motorized access on open space. The majority of respondents (78%) said they would like to continue to allow motorized vehicles up to a width of 50 inches on the Second Gulch Trail, whereas 22% supported increasing motorized vehicle width to allow access for modern OHVs.

Q7 What is your preferred management of motorized vehicles on the Second Gulch Trail within Town open space?

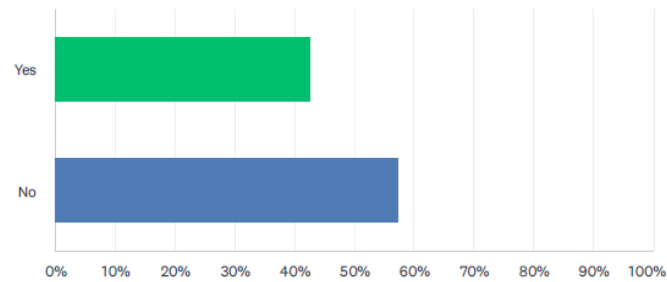

The final substantive question asked about respondents' support for increasing E-mountain bike (MTB) access on non-motorized dirt trails on open space. Question 7 and 8 had nearly identical results for Eagle residents only.

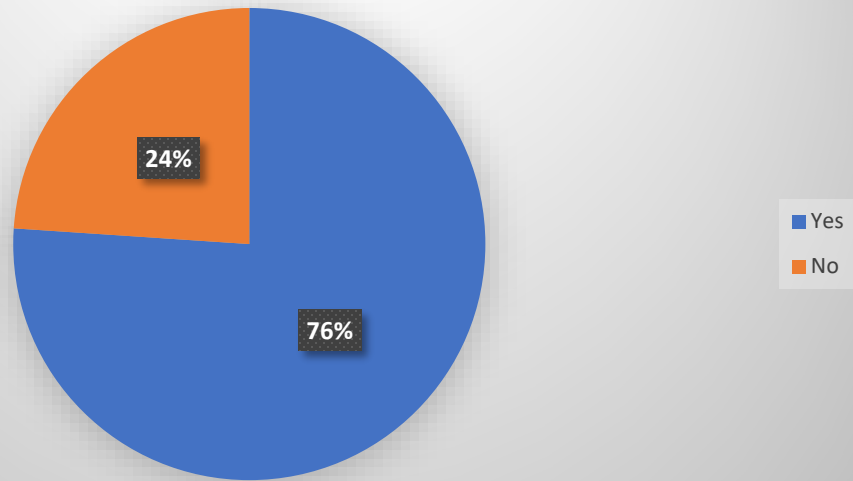

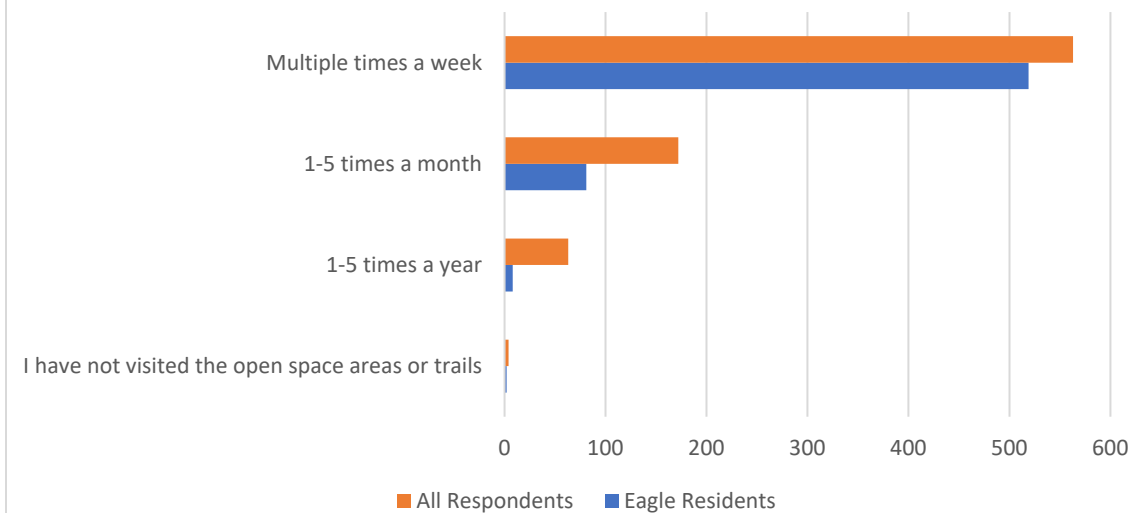

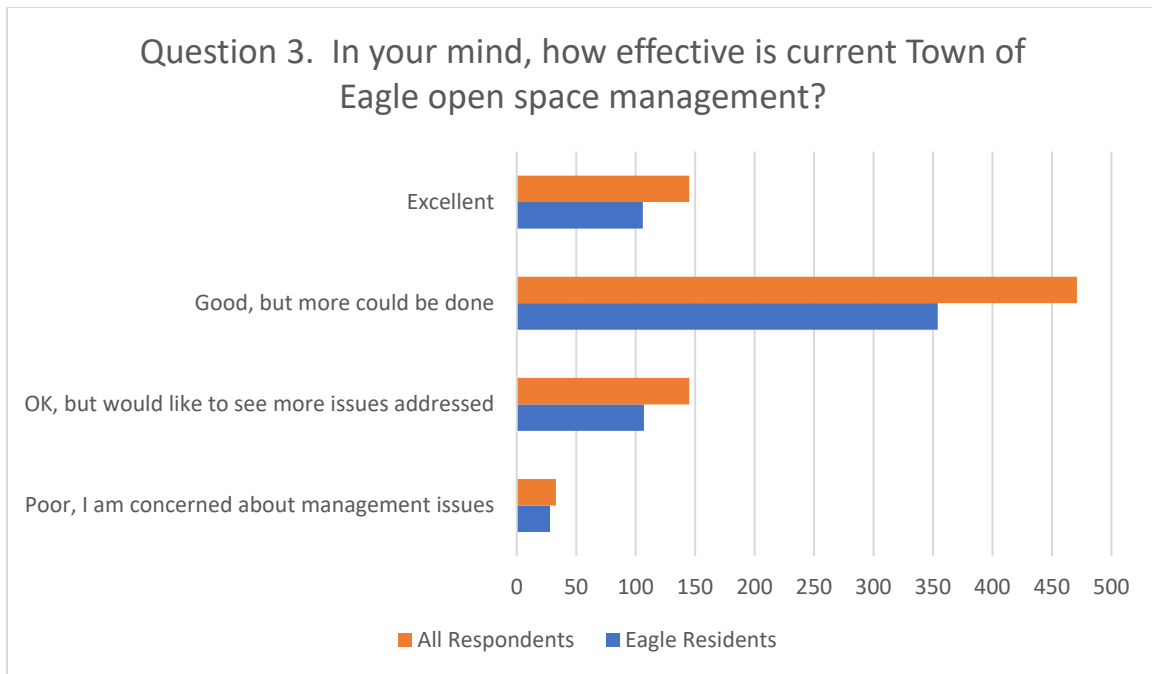

Question 2. How often do you visit the Town of Eagle's Open Space areas or trails?

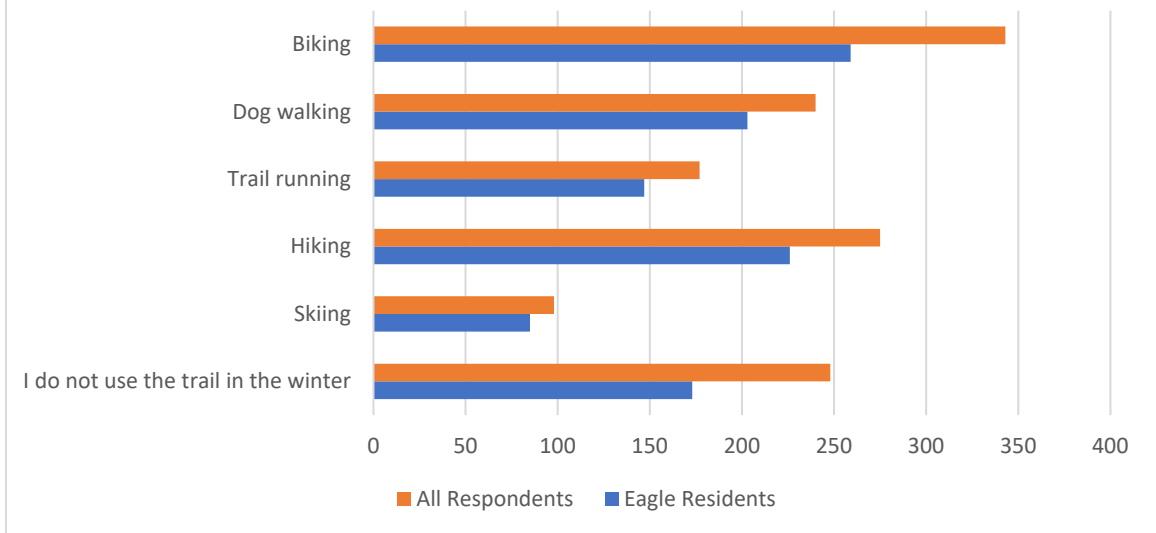




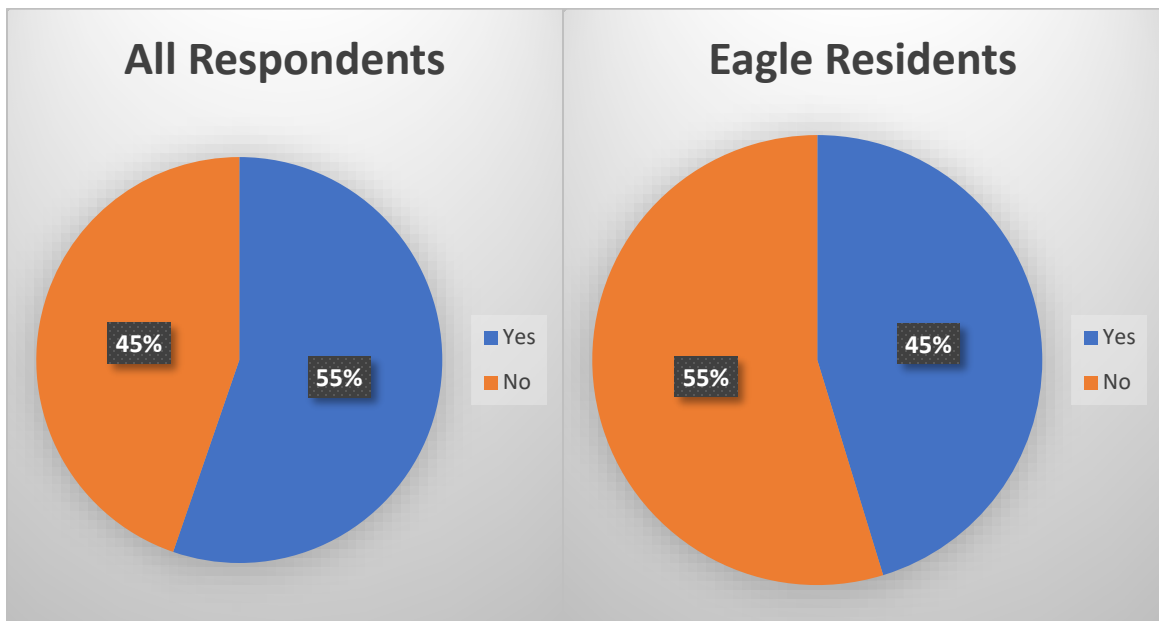

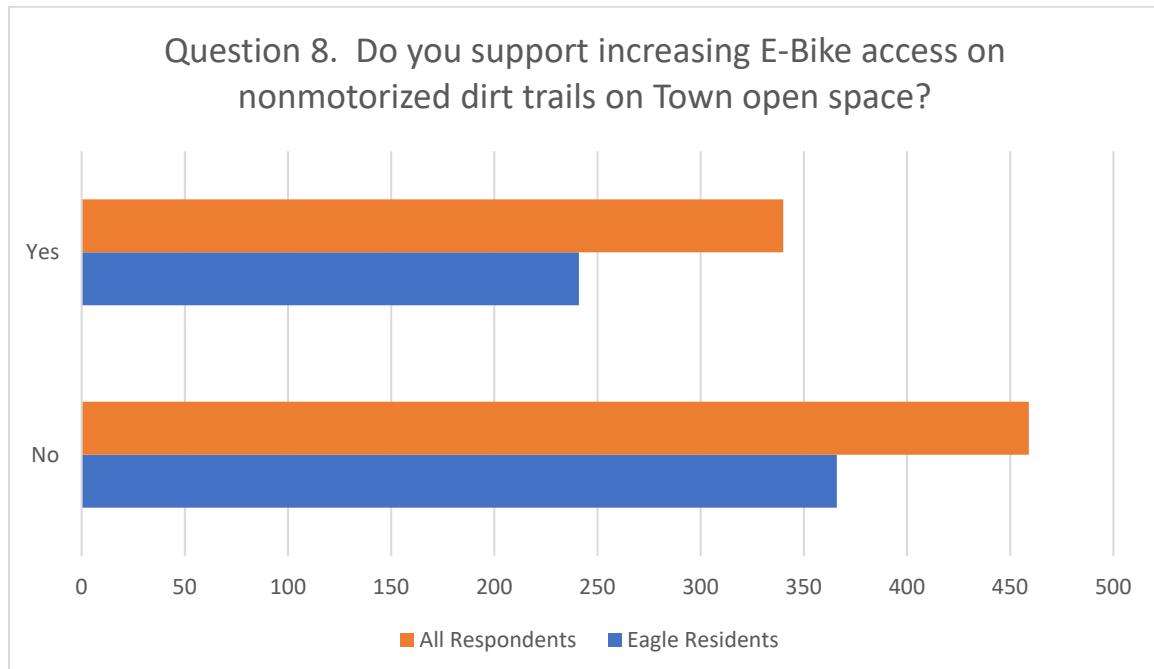
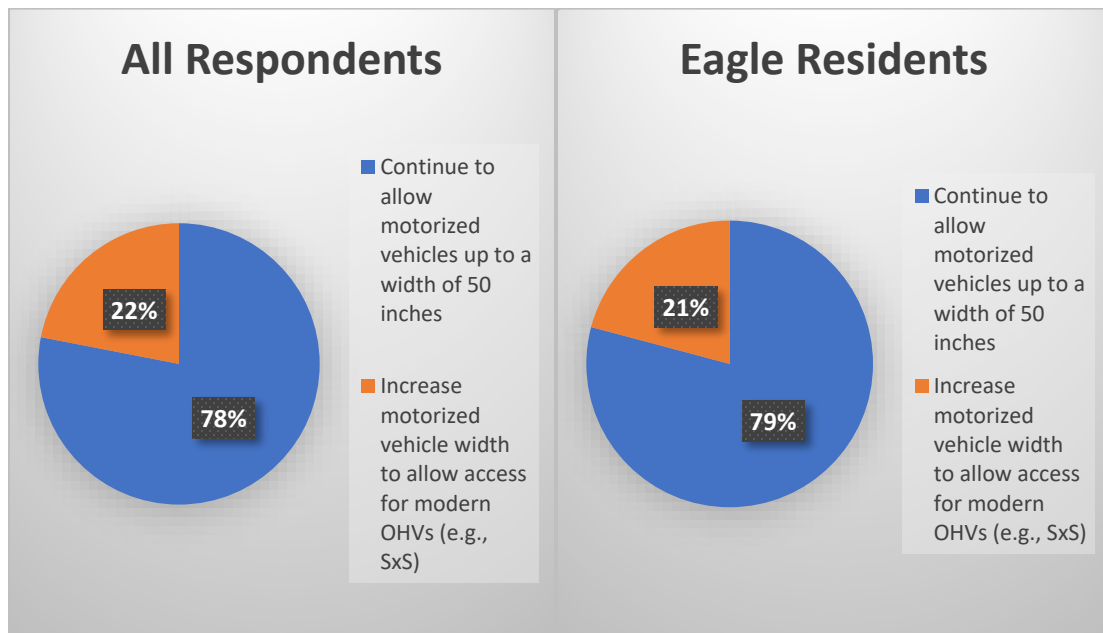
Question 5. What is your preferred use of the Haymaker Trail system in the winter? (check all that apply)



Question 6. Would you support additional winter restrictions on the Haymaker Trail system to protect wildlife?

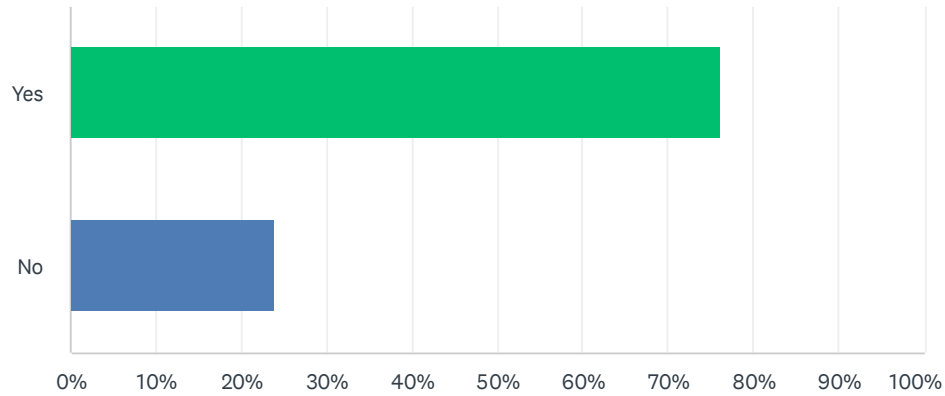


Question 7. What is your preferred management of motorized vehicles on the Second Gulch Trail within Town open space?

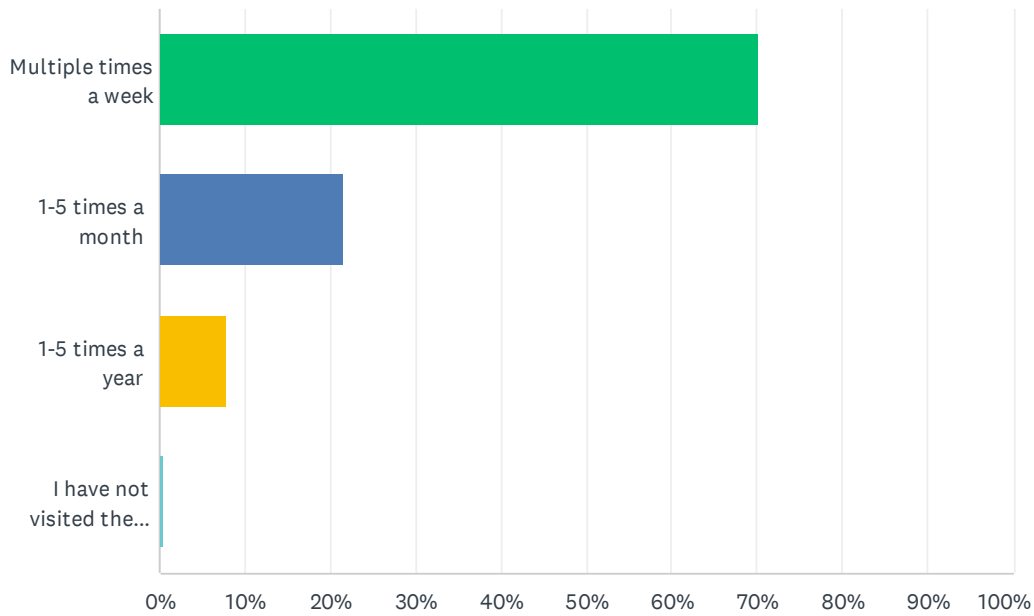

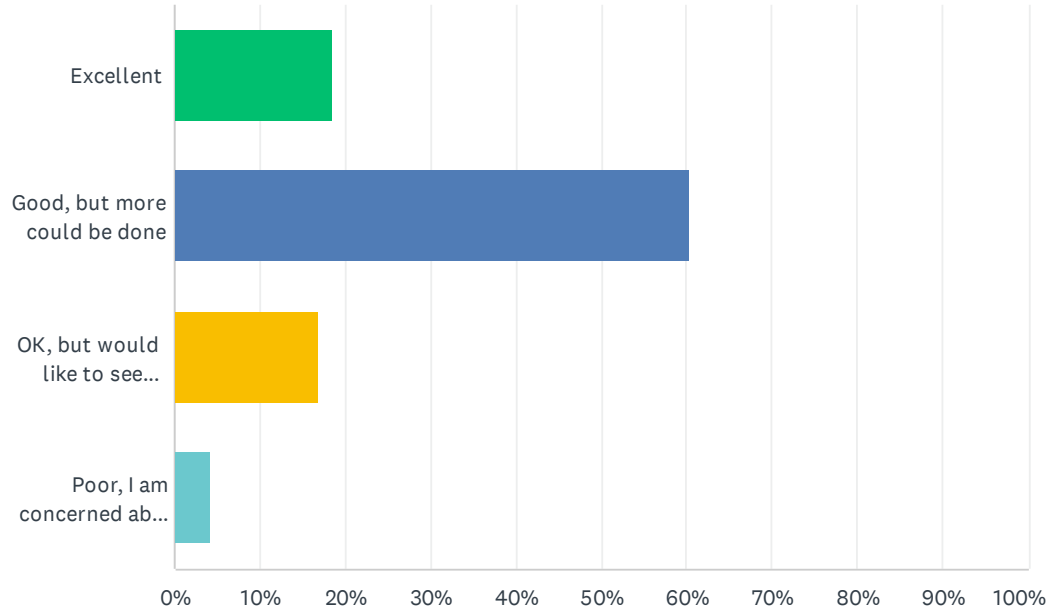

Q3 In your mind, how effective is current Town of Eagle open space management?

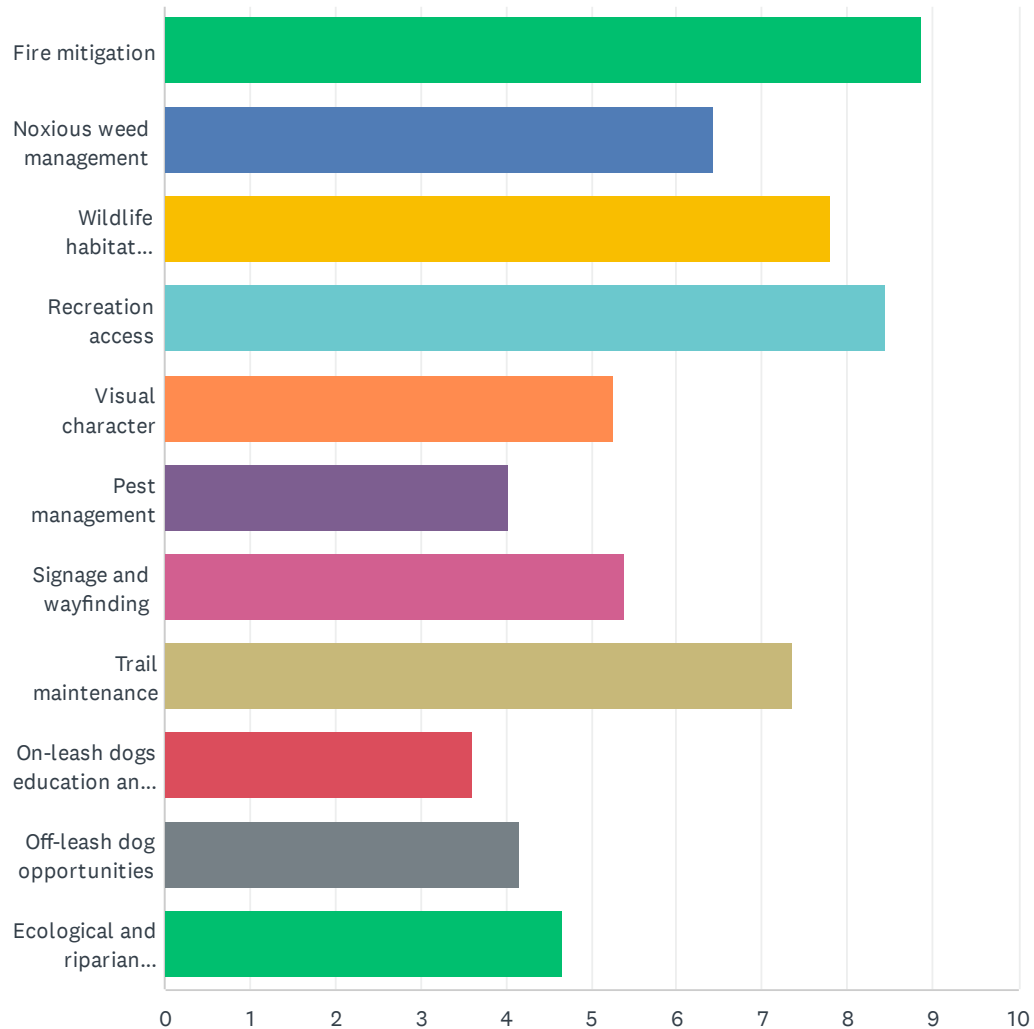

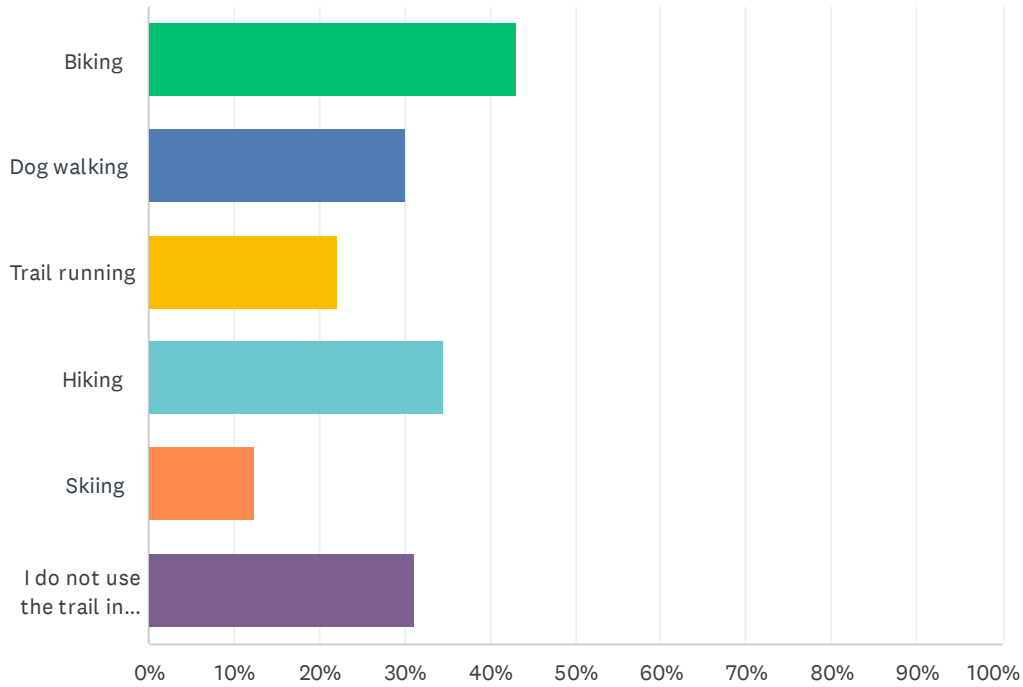

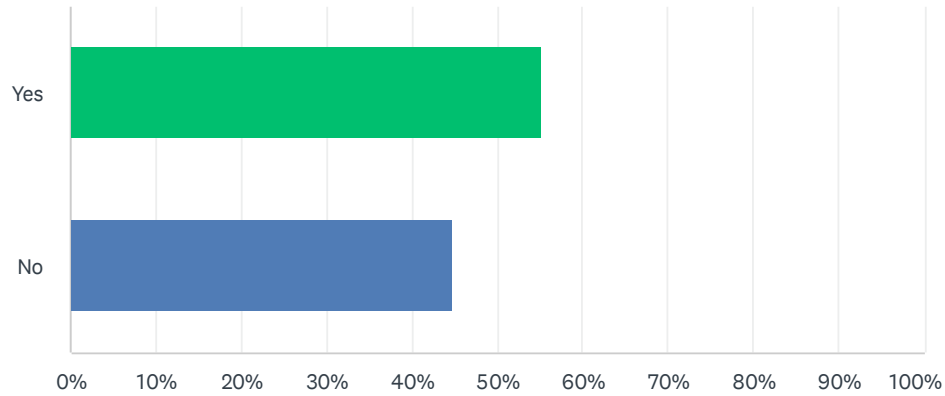

Q6 Would you support additional winter restrictions on the Haymaker Trail system to protect wildlife?

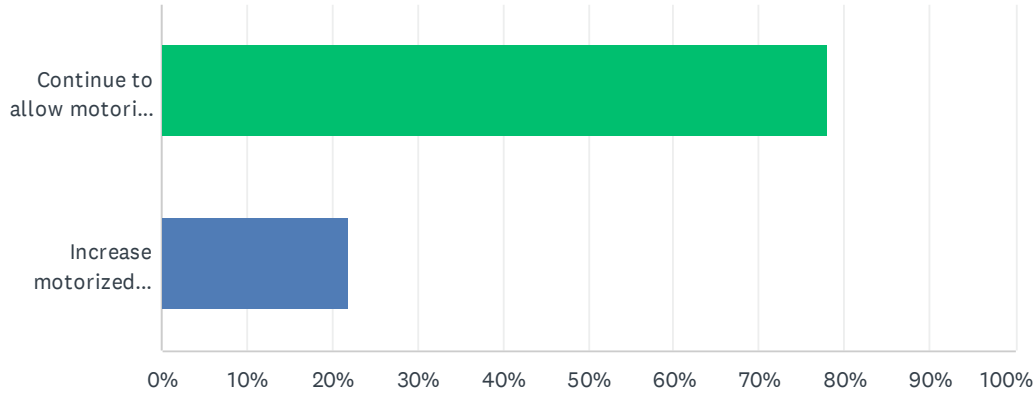

Q7 What is your preferred management of motorized vehicles on the Second Gulch Trail within Town open space?

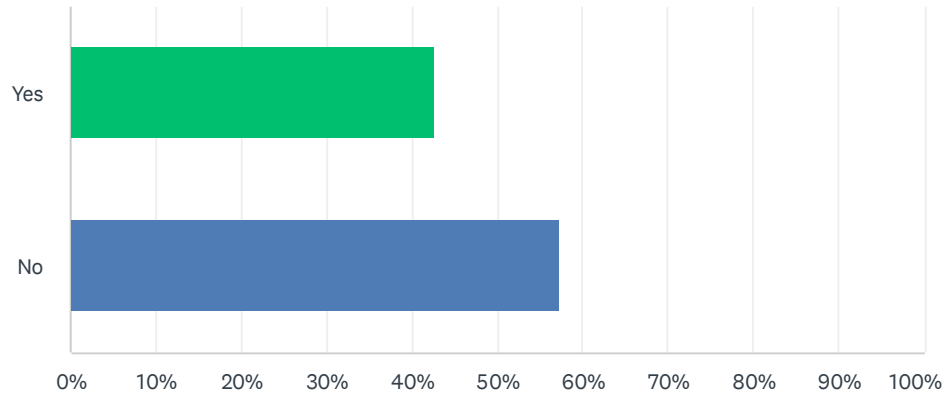

Larger motor vehicle use is not compatible with the heavy use of this trail use by vulnerable trail users, like hikers, runners, and bikers, many of them kids and seniors. Putting them both on one path would not only be an annoyance but a liability and safety hazard. Vulnerable trail users don't wear crash protection, have vehicle protection, or wear noise protection. Larger motorized vehicles already have multiple access points to the backcountry at Hardscrabble Road. Second Gulch access would only be shortcut for these vehicles to get into the backcountry hindering other no-motorized frequent users. The people who designed the trail to be hikers and MTB only, designed it with great insight. I recommend that additional access points for larger motorized vehicles are being considered in collaboration with the County. The thought that Eagle should solve this issue on its own versus working with the County is not acceptable. I also recommend Eagle learns from the town of Moab and how motorized back-county access has negatively impacted the quality of life of its neighborhoods. Solutions for backcountry motorized access should and could be found substantially outside the current and future residential areas and outside the areas frequented daily by vulnerable trail users' young kids and seniors. Let's try to keep the environmental impact on our neighborhood limited and preserve the nearby trails for less impactful recreational use with the safety of our kids and seniors in mind. I fear any type of limited motorized access can't be controlled and will likely mushroom. The late evening/night use by dirt bikes is an indication of what will happen at an increased frequency. Complaints at previous public hearings about this have been to no avail. There is ample access in the backcountry for larger motorized vehicles and new access can be created well outside the town's borders, so I don't see any valid reason to negatively impact those who live and/or visit the area and frequently use the trail to walk, hike, run and bike. Motorized vehicle access also accelerates the significant erosion on 2nd Gulch and the 2nd Gulch Hardscrabble connector. I believe the severally damaged cattle guard last year and fast erosion of 2nd Gulch – Hardscrabble connector demonstrated this already. Further trail damage would interfere with the frequent use of the trails by hikers, runners and gravel bikers. The trail from the Arroyo Parking Lot to the Cattle Guard sits in a natural amphitheater which substantially amplifies the noise of motor vehicles coming through it. This concern has been mentioned by other residents at a public hearing. I recommend that you study the noise impact/levels on the neighborhood before considering/proceeding. Note this is already a concern with the smaller motorized vehicles, especially since dirt bikes tend to use the road early and very late in the day. The noise would only increase with larger vehicles. We can literally understand every conversation people are having on the trail which is ~300 yards away. If you can overhear a private conversation just imagine the noise impact with an increased use of motorized vehicles. I noticed that most of the motorized vehicle user use substantial noise protection (noise cancelling headphones, earplugs). This proves that the drivers recognize that the noise levels are high and even harmful. However, they only seem to care about themselves but not about the people in their environment. A convenience for some should not be a hindrance and safety hazard for others. I am extremely concerned about the increasing motorized traffic on the 2nd Gulch Connector. Instead of allowing even more and wider motorized traffic it should be banned totally. Again, on Saturday night August 12th at 10.30 pm several dirt bikes came through revving with flashing white, blue and red lights as they continued to Hardscrabble Rd. and later back into 2nd Gulch. It just exemplifies the risk of increasing and broadening motorized access on 2nd Gulch and the significant impact it has on the nearby community. If people can't behave and follow some easy rules and respect the neighbors, no further privileges should be granted, and the community should be put on notice that even dirt bike access isn't guaranteed. We went from a quiet and family friendly Eagle Ranch community to neighborhood interrupted daily at sunset and early mornings by revving motorbikes. The survey for sure should have allowed for easier and more comments. The survey for sure should have allowed for easier and more comments and allow for non-binary answers. For example, I don't support motorized access on 2nd gulch and would have preferred to provide more nuanced comments/answers on all other survey questions. Please take the outcome with a big grain of salt. Regarding another matter. I also recommend that the Open Space Committee reviews and tightens access to the trials during excessive dry periods / days with high fire risk. I have personally seen how long it takes, despite best efforts, to get the fire crews up the gulch in case of emergency. The fire risk concerns me a lot. Any type of motorized recreational access to trials around town substantially increases this fire risk. I understand that further fire restrictions will require coordination among many agencies, but prevention is the better solution. A code change is overdue because of the significant expansion of the Eagle's population, its density, and its boarders. As such, I recommend a Code Change to significantly limit and/or ban fire-arm use, off-road recreational vehicle use, fireworks and party areas during days of very high fire risk and/or prolonged draughts. I would also recommend to substantially step up preemptive controlled fires/clearing of underbrush in areas surrounding Eagle. It doesn't make sense to restrict access in Haymaker areas for a longer period in spring given the high density of homes in the area. If there are valid concerns, haymaker shouldn't have been developed. Access period to trials should be the same everywhere. e-bikes use should be allowed but they need to yield to all non-motorized traffic in all circumstances and limit their speed on trials.

Town of Eagle Open Space and Trails Management Plans Engagement Opportunity Summary

Summary

The Town of Eagle has encouraged and solicited community input from the outset of the management planning process. As draft management plans and policy papers were developed and shared with the public, online and in person engagement opportunities were held as avenues for the public to provide feedback on the direction of the plans and recommended policies.

The online engagement opportunity was a questionnaire that asked the respondents to rank the level of agreement or disagreement with the recommended management plan topics and policies. The form was open for responses from October 11th to the 27th and rendered 284 responses. Below is a summary of the online engagement opportunity. Additionally, an open house was held at the Brush Creek Pavilion on Wednesday October 18th, 2023, from 4:30 to 6:30 and included a short presentation on the project. Over 130 people attended the open house and provided comments to the project team.

General Online Engagement Results

There were 284 responses to the survey with 82% of respondents reporting they reside in the Town of Eagle. There were 41 respondents who reported living in other areas of Eagle County and only 10 respondents who reported residing in an area outside of Eagle County. Eighty percent of respondents reported being older than 41 years of age.

Detailed Online Engagement Results

A series of questions asked the respondent to rank their support for the management plan topics and management recommendations for the three policy issues which are Second Gulch motorized access, Haymaker seasonal closures, and E-bikes. **Note:** The following results are equally representative of Eagle-only respondents as they are to all respondents. The compiled SurveyMonkey results are shown as an attachment at the end of this report.

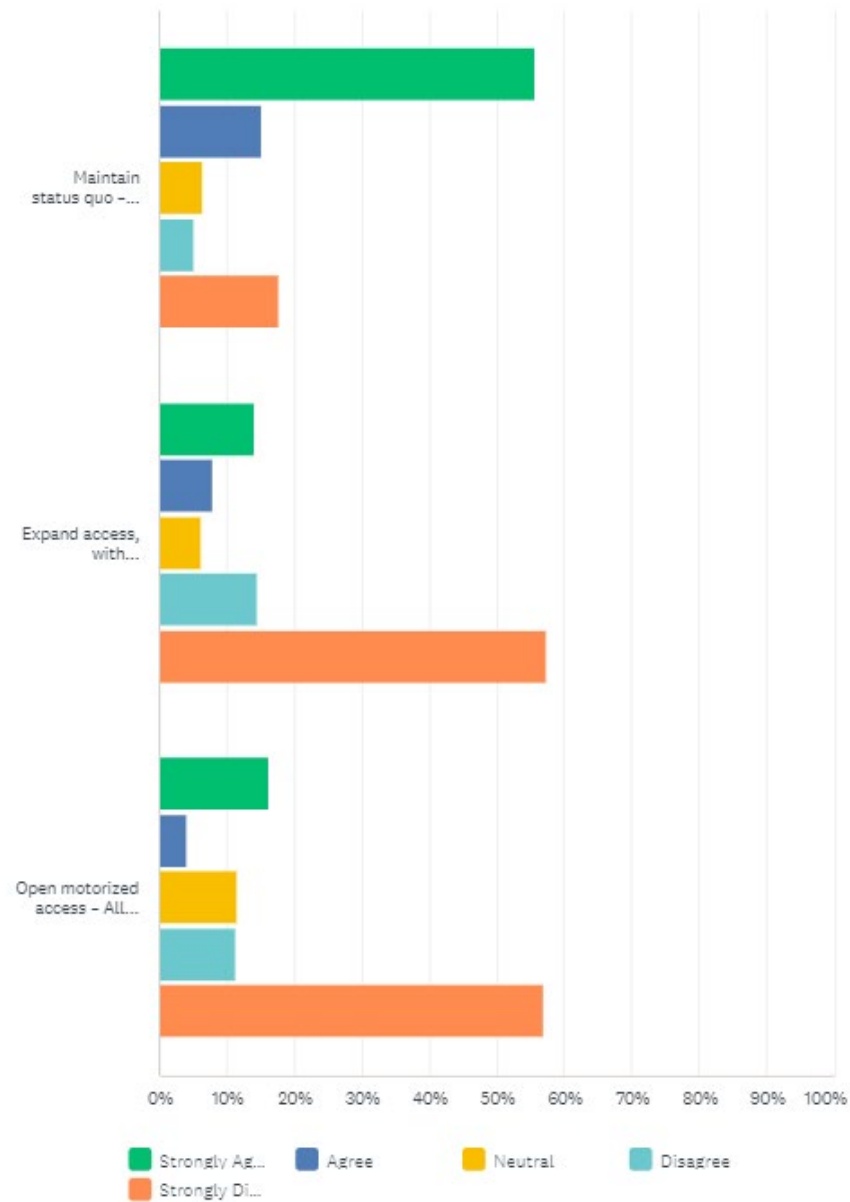
The first of these questions asked how supportive respondents are of the management plan recommendations by topic (from strongly agree to strongly disagree). Fire mitigation had the highest support for its recommendations whereas recreation access had the least support for its recommendations.

Next, respondents were asked to select their support for each of the three management options for motorized access to Second Gulch (from strongly agree to strongly disagree). For maintaining the status quo, which would be no change to the existing management of 50-inch vehicle width limit, most respondents strongly agreed. For expanding access to allow UTVs and other modern recreation vehicles, most respondents strongly disagreed. For the last option, to open motorized access to all vehicles and uses, most respondents also strongly disagreed. Additionally, another question asked if respondents agreed or disagreed with ERO's recommendation to develop a community process to define a consensus recommendation for Second Gulch. Around 54% of respondents agreed with this strategy, while 46% disagreed.

How do you feel about each of the three management options for motorized access to Second Gulch?

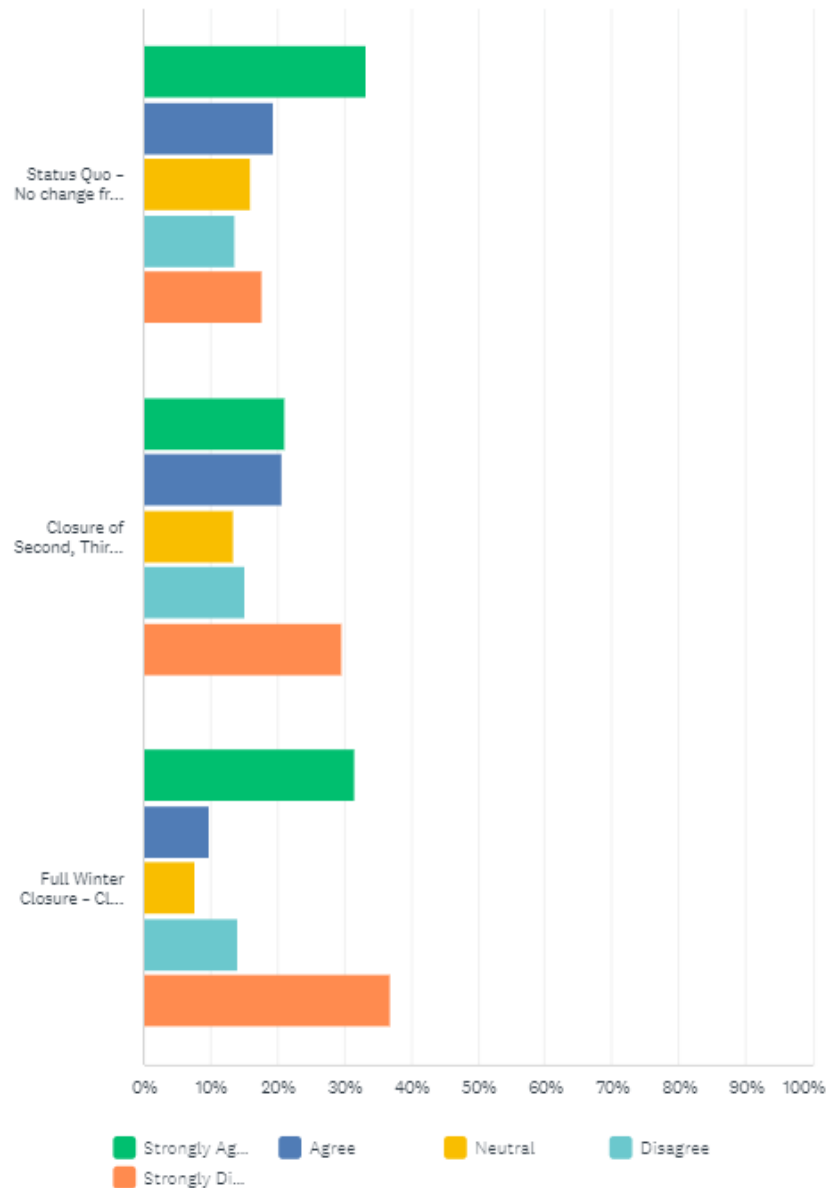

The next question asked participants to select their support for the three possible management strategies of the Haymaker Trail system regarding seasonal closures for wildlife protection (from strongly agree to strongly disagree). How do you feel about each of the recommended management strategies for the Haymaker Trail system?

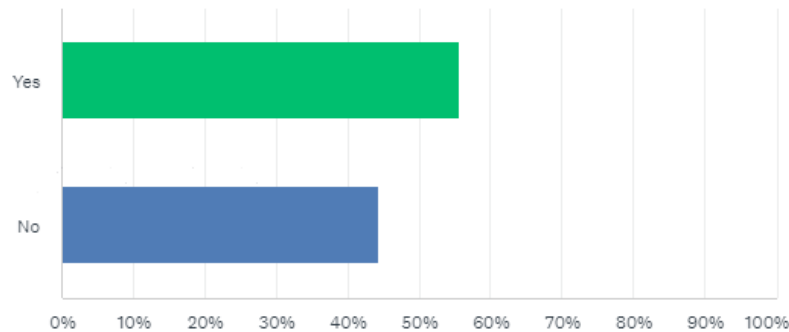

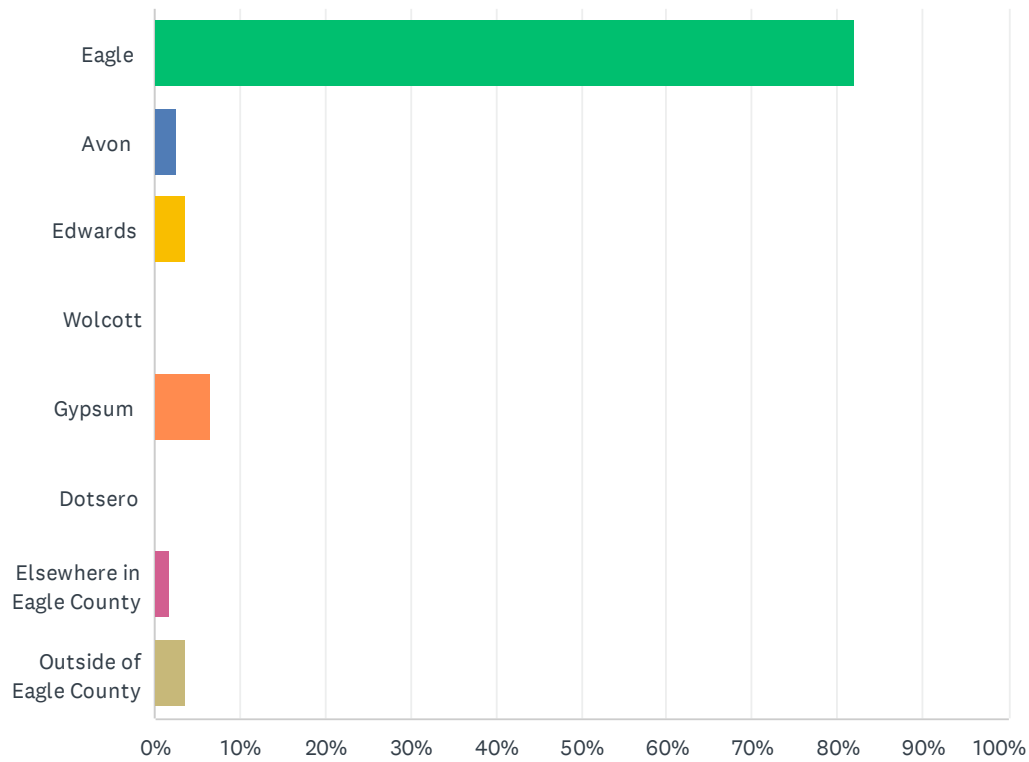

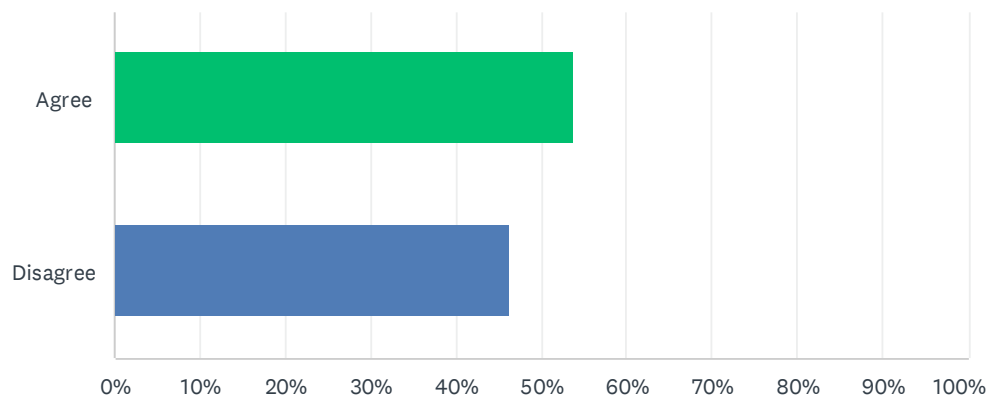

Q7 How do you feel about each of the recommended management strategies for the Haymaker Trail system?

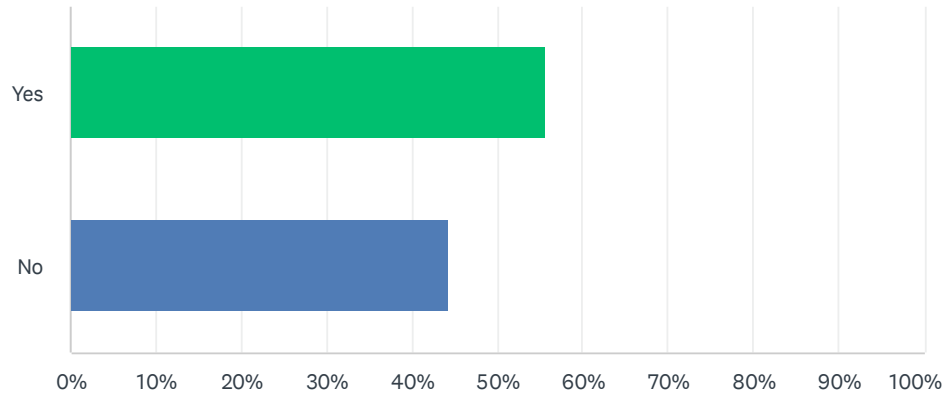

OSMP Public Comments 9.5.23 – 11.7.23

Dear Brian and Committee members'

Priority #1

In response to the meeting September 5th. Why are our tax dollars funding third party analysis? CPW had established Critical Wildlife Habitat areas which include the haymaker trail for winter closures. This was sited years ago even before the hay meadow development was approved. This is nothing new. Brian Woodrich, our CPW officer with 28 years of education and field experience stood in front of the committee stating the need for winter closures for this trail due to its location within winter range, and the south facing slopes it boasts. There is no room for interpretation here. It is clear and if the town chooses to ignore this information there will be irreversible damage. Yes, some may be angry with your decision to close the trail, but this is your job!! You were hired to manage the open spaces for recreation and wildlife. There is a balance that needs to be maintained and winter trail closures are a part of that balance. You must make this decision now. Set in place the expectation before the first Haymeadow resident moves in, otherwise every person will think that these trail are fair game any time regardless. If we act now, the president will be set. Do not drag your feet or this will become an uphill battle. You have all the facts you need and a community majority who supports you. Be bold!

Priority #2

I am very disappointed there has been no more mention of equine only trails or equine connectivity. I would like to see an equine only trail based out of pool and Icerink parking lot leading up to the Boneyard area and circling back around haymaker by way of Road Gulch. I would also like to see a foot path along Brush Creek Rd. There are numerous families along Brush Creek with horses that cannot ride out their doors for fear of risking life and limb on Brush Creek Rd. Our only option is to cross the creek into open space. This summer one of my horses tore a ligament in this open space due to the unstable footing (gofer holes and tall grass) because we are not permitted to walk them along the crusher fines trail. This is how we get to the Riddle trail. We should have the same accessibility to trails as the mountain bikers! We feel very overlooked and excluded from these plans. Please let me know what your thoughts are on improving upon and eliminating this deficiency.

Priority #3

Recreation is important and you have ignored Hunting as a valued recreation in Eagle. This is a huge revenue for Colorado and should not be devalued. The once prevalent "welcome hunters" signs are now replaced with mountain bike race days and our once quiet forests are now infiltrated with bikers. It use to be that once hunting season opened, folks stayed out of the woods to allow hunters their time, not to mention avoid flying bullets and arrows. What can the town do to respect hunting season? Trails and open space needs to include this in its plan!

I look forward to hearing your thoughts and responses for all who have inside.

Hey Brian, I just heard that it's likely Haymaker will be closed all winter. Here I list a few points that I will regularly communicate to customers and as much as possible to the town in general as I'll have more time this autumn to do so.

Closing Haymaker in the winter has no basis in science. Haymaker's usage has no proven impact on local wintering wildlife. All herds are within CPW goals.

This open space is being paid for by residents. Losing winter access is a loss of value of local tax money.

Closing Haymaker puts more stress on the Bluffs. Because there are limited outdoor spaces in Eagle available for winter recreation, all the traffic that normally uses Haymaker for winter recreation will now move to Boneyard/Bellyache Rd. This will add congestion in that neighborhood, which already has limited parking opportunities in the winter.

Without any scientific basis, public space is being reduced. This sets the precedent that any public space is subject to arbitrary closures. Our space is not our own, and belongs to only a few influencers. This closure, along with other current standing closures, are, at best, bad decisions. At worst, they are infringing on our access to public open space such that a few users and/or homeowners maintain a space that is desirable to themselves at the expense of the general population. This could be considered a basic civil violation by a State agency.

There are some in my social circle who believe that Haymaker closing is something that will never be reversed. Be aware, if the Town pursues this action, it will re-open along with every other access point so long that it's legally viable. Closing Haymaker in the winter will be the Town of Eagle "choosing a side" and it will be the losing side.

No hate on you Brian, you're good people and I'm sorry I need to send a harsh letter through you. But, I've lived here long enough to stand up for what's right. Taking opportunities to recreate from the general public with no evidence of disturbance on the ecosystem is absolutely wrong.

I was reading the Vail daily article about how the BLM is considering the 52 " rule in 2nd Gulch. One concern is the noise and activity from the larger UTVs. If you want to know how loud and noisy it gets, just spend some time at the boneyard trail late on Friday or Saturday nights and you can observe the dust, motor noise, and trash left behind by users between 11 pm and 3am. We live nearby and can't leave our windows open at night due to noise and dust in the summer. It's definitely a party scene all night long!

Hi Brian, Town Council,

I won't be in Town for the open house so just wanted to add to the conversation and public input:

1. Haymaker should be closed but all points of access to Bellyache should also be closed throughout the winter seasonal closure period if you really want to positively impact local deer and elk herds. I don't think that is practical dealing with the BLM and Bluffs residents but it would be a huge gain for elk and deer.
2. People can and do recreate on the golf course trails through winter, the variety in riding isn't really justified to keep Haymaker open at the expense of local wildlife.

The “Keep the 50” Rule for off-highway vehicles at 2nd Gulch” is an attempt by a small group of passionate people who lack in facts the totality of their requests.

With regard to the Haymaker Trail winter access, I support the recommendation of winter closure of Second, Third, and Extra Credit. I understand that these areas are not far from development. But that is not relevant. I live in an area that is frequented by the elk herd in the winter. They roam our neighborhood without being disturbed by the houses. What disturbs them are people who don’t understand the need to leave them alone, and dogs.

I want to stress what I think is the most important issue here — off-leash dogs. We simply have to make sure that there are no off-leash dogs on our trails during the winter months. Enforcement is critical. We need to be using wildlife cameras, signs, and consequences.

With regard to Second Gulch, I support maintaining the status quo. The current situation, with the 50-inch limit, has existed for a long time. There was and is no overwhelming desire within the community to change it. Taking months to hire a facilitator and try to come up with a compromise is foolish. We know the facts, and we know the results of the survey, which shows the vast majority want to keep the status quo. It’s time to make the decision to keep things as they’ve been for many years.

Appendix B. Harrington's Penstemon Background and Conservation Measures

Harrington's penstemon (also known as Harrington's beardtongue; *Penstemon harringtonii*) is a vascular plant species that is known to occur in a narrow range within the Colorado River drainage in northwest Colorado. This species generally occurs in dry, sagebrush-dominated communities at elevations between 6,400 and 9,400 feet. Within this narrow range, the total population of this species is estimated to be located within about 15 square miles of habitat, including the sagebrush-dominated slopes in and around the Town of Eagle (CNHP 2006).



Status

This species is not listed under the federal Endangered Species Act or the Colorado Threatened and Endangered List, but is considered a G3/S3 ranked species, meaning that it is considered “vulnerable” at both the global and state scales (CNHP 2015). It is considered to be a BLM Sensitive species (BLM 2020) and a USFS Region 2 Sensitive Species (Forest Service 2023).

Habitat

Harrington's penstemon occurs in open sagebrush and mixed pinyon-juniper, Gambel's oak or mixed mountain mahogany shrubland habitats on gentle slopes. Soils are generally rocky loams and rocky clay

loams, as well as limey shales, limestones, and other rocks, though it is not known whether the species is limited to specific geologic substrates or soils. *P. harringtonii* has been documented on all aspects and on slopes as steep as 50 percent, but is typically found on slopes less than 20 percent (CNHP 2006).

Description

Plants are perennial, and are about 30-70 centimeters tall, typically with a single unbranched stem. Flowers are pink to purple or blue, and are arranged in loose spikes on the upper half of the stems, typical of a traditional snapdragon (it is a member of the Scrophulariaceae, Snapdragon or Figwort family). Flowers are in loose spikes with two exerted stamens (stick out of the flower tube). Leaves are thick, rounded, and elongated in shape, are bluish grey in color, and are arranged opposite each other along the flowering stem and in a basal rosette at the base of the plant. Flowering typically begins in early June and continues through late June (CNHP 2006).

It is similar in habitat and appearance to Osterhout's beardtongue (*P. osterhoutii*), which are more likely to occur in pinyon-juniper dominated areas, but are sometimes mixed with *P. harringtonii* (CNHP 2006).

Threats

Threats to the species include grazing, recreation, roads, and other development that may result in the trampling of plants, removal or fragmentation of habitat, loss of pollinators, effects of climate change, and/or the proliferation of invasive, non-native plant species such as cheatgrass, Canada thistle, smooth brome, musk thistle, and houndstongue (CNHP 2015, NatureServe 2023).

Potential Habitat Assessment

ERO assessed potential habitat for *P. harringtonii* on Town of Eagle open space land on June 28, 2023. Habitat includes most sagebrush-dominated habitat and in some areas adjacent to known populations on BLM land. Suitable habitat is present on Town of Eagle open space land. ERO did not conduct a comprehensive survey for *P. harringtonii*, however individual plants were observed in the Town's open space in the sagebrush-dominated areas and occasionally in the mixed montane shrubland and pinyon juniper communities.

Conservation and Project Implementation Measures

To support the long-term conservation of this species, the following measures are recommended for any ground-disturbing activities within identified potential habitat:

1. Survey proposed project areas during the survey period (June)
2. If found, evaluate or modify the proposed project to avoid ground disturbance within a 100-foot buffer of all confirmed plants
3. If a 100-foot buffer cannot be implemented, avoid direct ground disturbance where plants are rooted.
4. If direct ground disturbance cannot be avoided, adjust the project site or alignment to minimize impact to the plants, with the goal of having less than 1 to 2 percent of the population within the project impact area.
5. If the project site or alignment cannot be changed to minimize impacts, confine disturbances as close to outer edge of the plant population as possible to minimize fragmentation.

6. If plants are unavoidable, contact nearby botanical gardens or grow out facilities (such as the Betty Ford Alpine Garden in Vail and the Upper Colorado Environmental Plant Center facility in Meeker; these facilities have accepted salvaged plants in the past) to salvage plants if possible.
7. Weed control efforts should not include broadcast or aerial herbicide treatments within ½ mile of known populations. Utilize spot spray application in these areas.
8. Construction within identified *P. harringtonii* habitat should occur during the active growing season (May 15 through August 30) to ensure that all rosettes are visible.
9. Monitor on-site construction with a qualified biological monitor (botanist) to avoid and mitigate impacts to populations.
