**AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF EAGLE, COLORADO  
AMENDING SECTION 8.12.020 OF THE EAGLE MUNICIPAL CODE, FOR PURPOSES  
OF ANIMAL CONTROL ON GOLF COURSES**

WHEREAS, to promote the public health, safety, and welfare, the Town seeks to clarify the definitions of "common ground" and "premises" in the Eagle Municipal Code, as related to animal control on golf courses in the Town.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF EAGLE, COLORADO AS FOLLOWS:

Section 1. The definitions of "Common ground" and "Premises" in Section 8.12.020 of the Eagle Municipal Code are hereby repealed in their entirety and reenacted as follows:

**8.12.020. – Definitions.**

\* \* \*

*Common ground* means the yard of any multiple occupancy building; a common area of a mobile home park, apartment or condominium development; an open space area of a subdivision not owned by the Town; and an area that constitutes an access to public right-of-way; but excludes the following: golf courses; sidewalks; and public recreation trails.

\* \* \*

*Premises* means property owned or leased by an owner or lessee, including without limitation any confined area or locality such as a residence, business, room, shop, building, or motor vehicle, including the open space bed of a truck.

Section 2. Severability. If any article, section, paragraph, sentence, clause, or phrase of this Ordinance is held to be unconstitutional or invalid for any reason, such decision shall not affect the validity or constitutionality of the remaining portions of this Ordinance. The Town Council hereby declares that it would have passed this Ordinance and each part or parts hereof irrespective of the fact that any one, or part, or parts be declared unconstitutional or invalid.


Section 3. Safety. This Ordinance is deemed necessary for the protection of the public health, safety and welfare.


