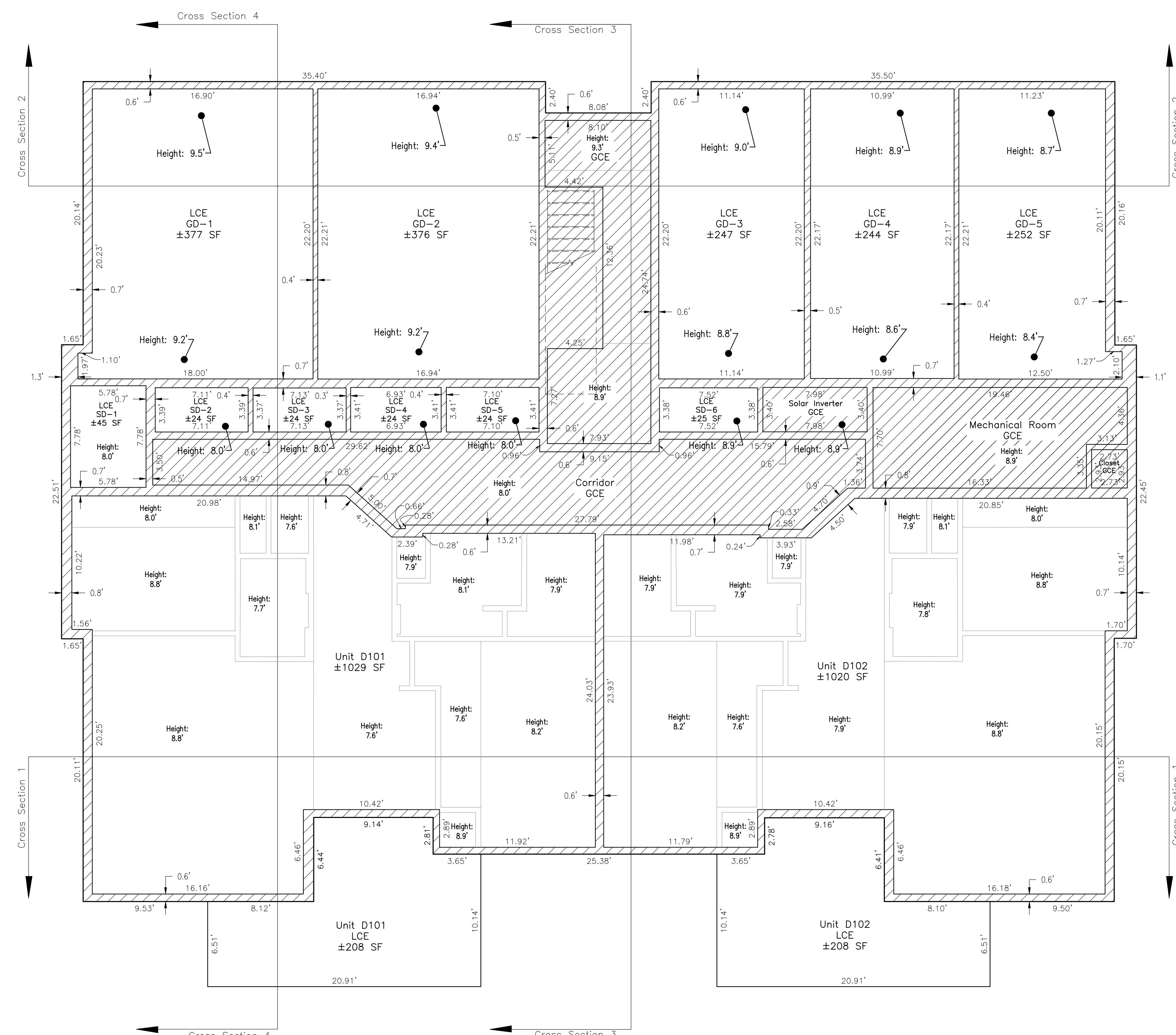

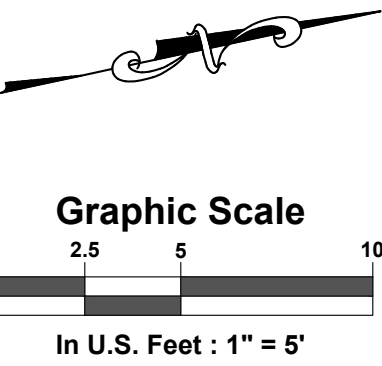

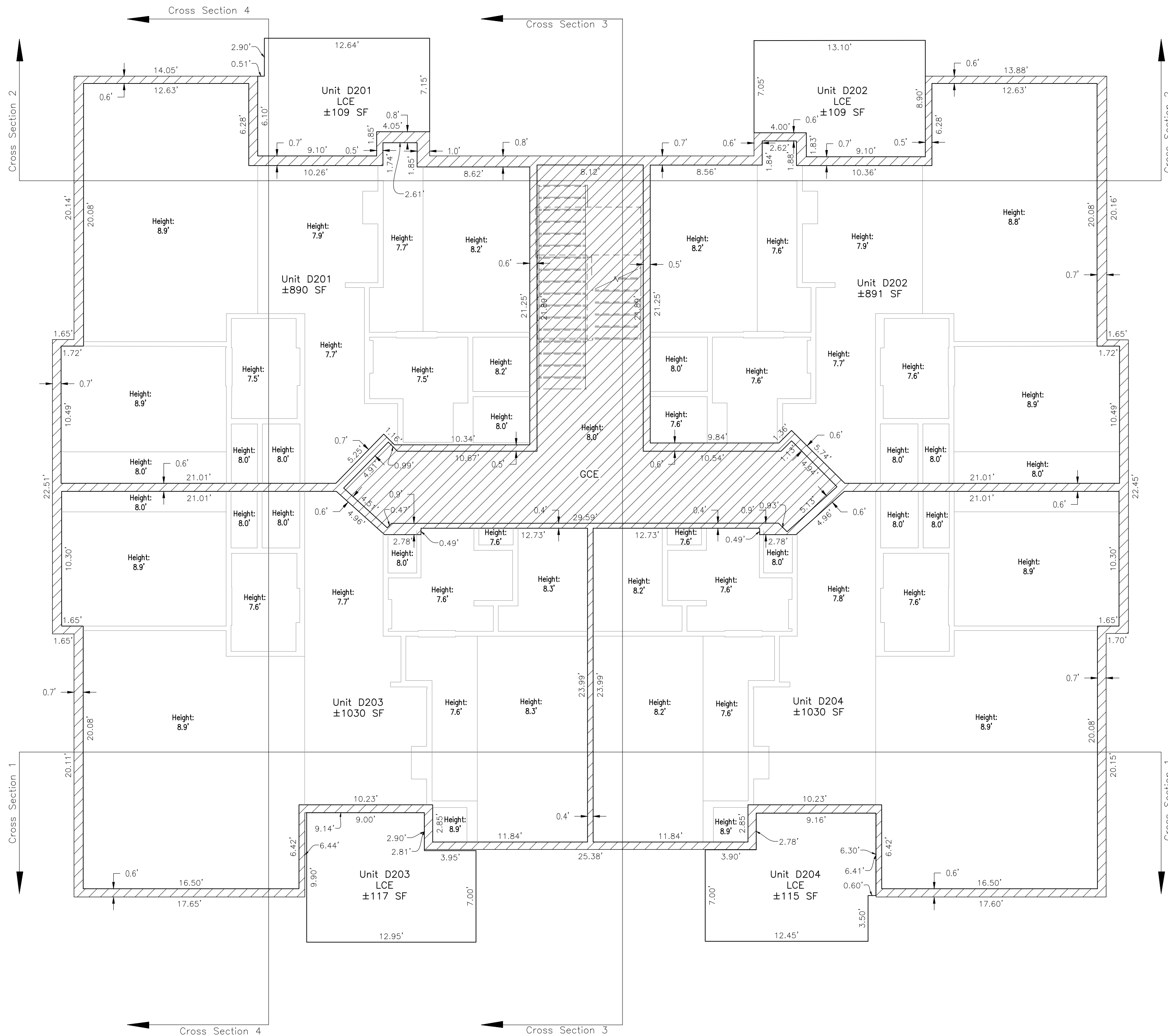

Interior Plan View

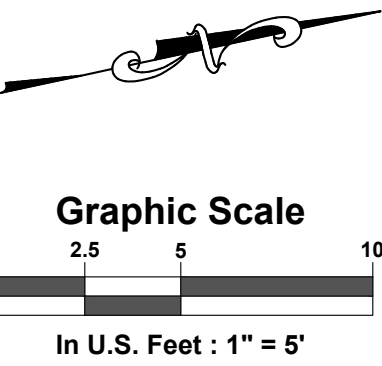

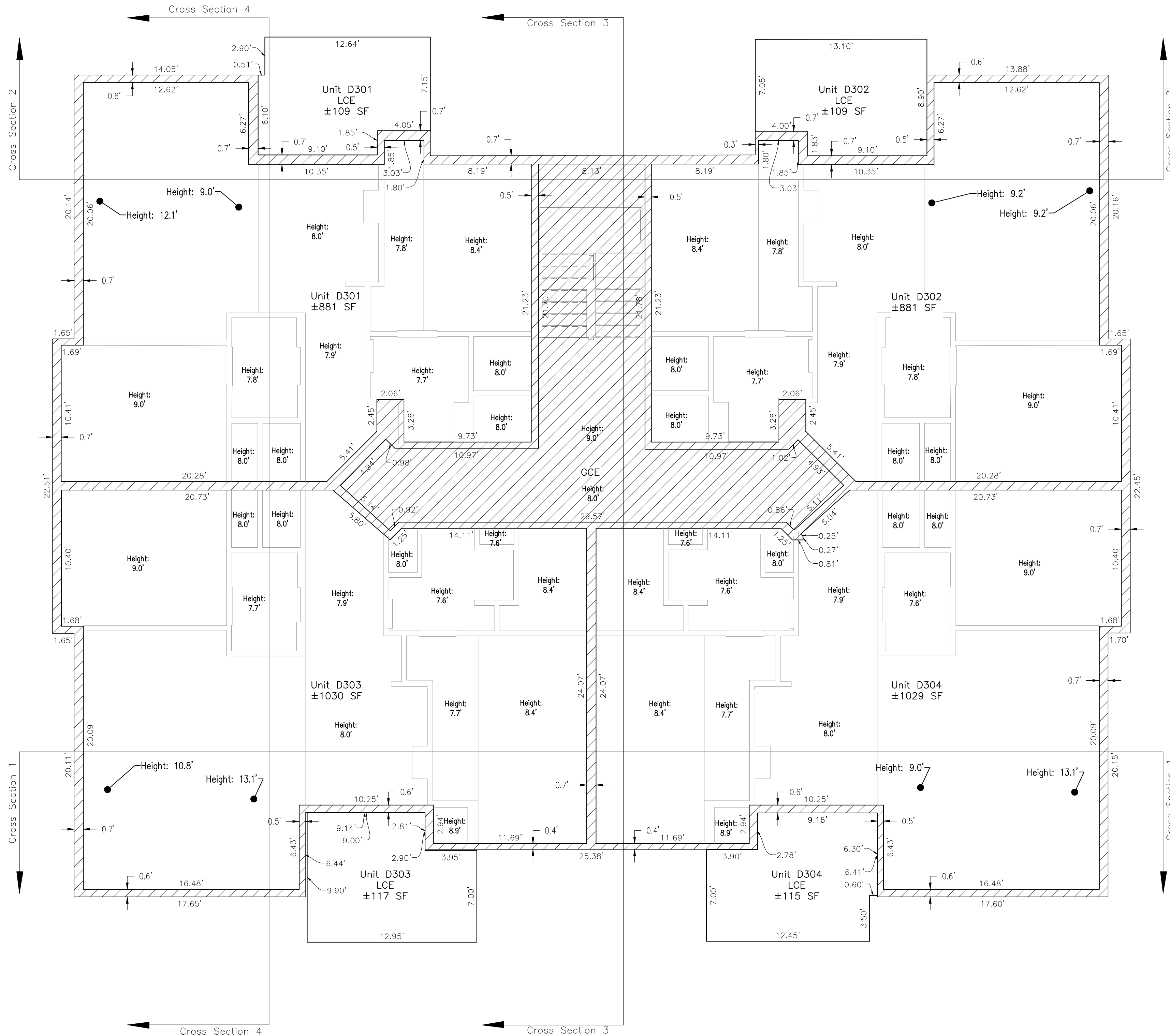

Interior Plan View

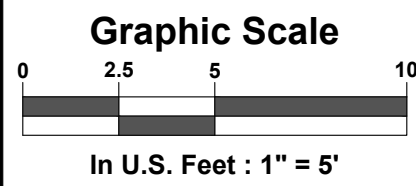

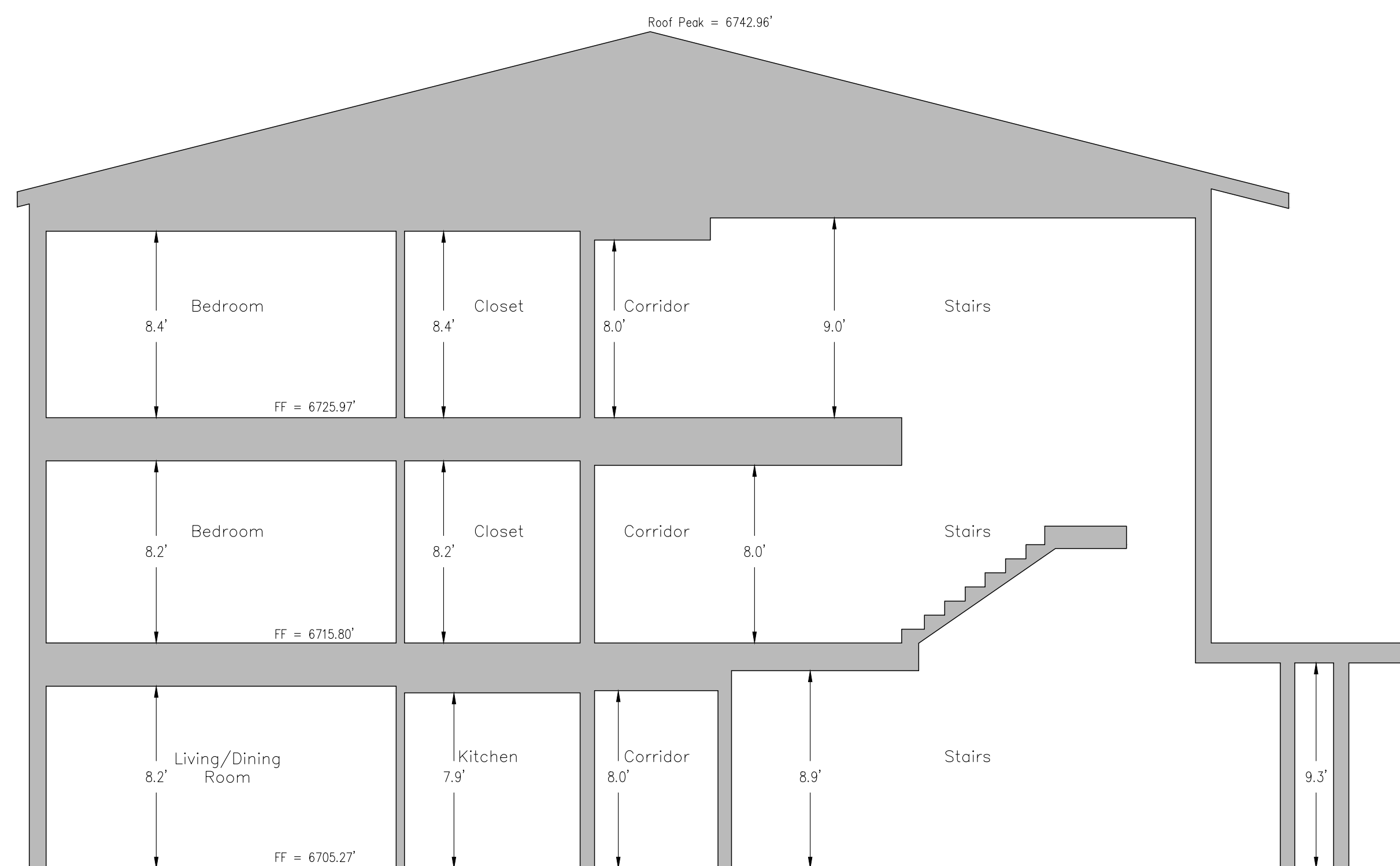
