

**TOWN OF EAGLE, COLORADO
ORDINANCE NO. 9
(Series of 2025)**

**AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF EAGLE, COLORADO, APPROVING THE
PURCHASE OF REAL PROPERTY LOCATED AT 678 GRAND AVENUE**

WHEREAS, the Town of Eagle ("Eagle" or the "Town") is a home-rule municipality organized under Article XX of the Colorado Constitution and with the authority of the Town of Eagle Home Rule Charter (the "Charter"); and

WHEREAS, the Town has authority under the Charter Section 12.01 to acquire real property by ordinance in furtherance of lawful public, local, and municipal purposes; and

WHEREAS, the Town evaluated the acquisition of a tract of land located at 678 Grand Avenue in Eagle, Colorado, more particularly described as MAYERS ADDITION TO EAGLE Block: 39 Lot: 2 (the "Property") as part of its Grand Avenue Project; and

WHEREAS, the Town Manager, on behalf of the Town, entered a purchase and sale agreement on September 16, 2025, to acquire the Property at fair market value (the "Contract") attached hereto as **Exhibit A**; and

WHEREAS, the Contract was conditioned on Town Council's final approval.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF EAGLE, COLORADO,
THAT:

Section 1. Incorporation of Recitals. The foregoing recitals are incorporated herein as if set forth in full.

Section 2. Contract. Town Council hereby approves the purchase of the Property and the Town Manager's authority to enter the Contract on behalf of the Town.

Section 3. Closing. Town Council further authorizes the Town Manager to execute any additional contract and closing documents needed to complete this transaction.
